

**RESOLUTION No. 23-65**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AWARDED REQUEST FOR PROPOSALS #2022-26 “INSTRUCTIONAL TENNIS PROGRAMMING AT DORAL LEGACY PARK” TO THE SECOND RANKED FIRM, AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH TECHTAFIME TENNIS LLC FOR THE PROVISION OF INSTRUCTIONAL TENNIS PROGRAMMING AT DORAL LEGACY PARK FOR A PERIOD OF THREE (3) YEARS WITH TWO (2) ONE (1) YEAR RENEWALS; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral (the “City”) previously issued Request for Proposals (“RFP”) #2022-04 on February 17, 2022 and RFP #2022-16 on April 29, 2022 for the provision of Instructional Tennis Programming at Doral Legacy park, and both RFPs were subsequently cancelled; and

**WHEREAS**, thereafter, the City issued Request for Proposals (“RFP”) #2022-26 on November 9, 2022 for the same services; and

**WHEREAS**, a mandatory pre-bid meeting was held on November 22, 2022, and two (2) submittals were received on December 8, 2022, with both submittals meeting the required criteria; and

**WHEREAS**, a Phase I evaluation meeting was held on March 29, 2023, where submittals received were scored—the scoring for Phase I was as follows:

**WHEREAS**, the evaluation committee chose not to proceed with Phase II evaluations (i.e., presentations) and recommended based upon the Phase I scores; and

**WHEREAS**, after conducting her due diligence, the City Manager believes that Techtafime Tennis LLC’s bid best serves the interests of and represents the best value to

the City; and

**WHEREAS**, the City Manager's Office respectfully requests approval from City Council to award RFP# 2022-26 "Instructional Tennis Programming at Doral Legacy Park" to the second ranked firm and authorize the City Manager to negotiate and enter into an agreement with Techtafime Tennis LLC for the provision of providing Instructional Tennis Programming at Doral Legacy Park for the City of Doral Parks & Recreation Department for a period of three (3) years with two (2) one (1) year renewals; and

**WHEREAS**, the City and the provider will split the revenue generated from the program's registration on a 70%-75% / 30%-25% split (70%-75% Provider / 30%-25% City) with the provider handling all registrations. The revenue split will be paid by the provider to the City and deposited into GL account 001.9000.347403 (Recreation-Tennis);

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval & Authorization.** The Mayor and City Councilmembers hereby approve the award of Request for Proposals #2022-26 to the second ranked firm and authorize the City Manager to enter into an agreement with Techtafime Tennis LLC for the provision of Instructional Tennis Programming at Doral Legacy Park for the City of Doral Parks & Recreation Department for a period of three (3) years with two (2) one (1) year renewals, on a revenue share 70%-75% / 30%-25% split (70%-75% Provider / 30%-25% City). The agreement is subject to approval by the City Attorney as to form and legal sufficiency and on such other terms and conditions as may be appropriate to protect and

further the interest of the City.

**Section 3. Implementation.** The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

**Section 4. Effective Date.** This resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Councilmember Puig-Corve who moved its adoption. The motion was seconded by Vice Mayor Pineyro and upon being put to a vote, the vote was as follows:
