## **RESOLUTION No. 17-43**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AWARDING REQUEST FOR PROPOSALS #2016-40 "YOUTH SOCCER PROGRAM MANAGEMENT" TO DORAL SOCCER CLUB, THE TOP RANKED FIRM; AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH DORAL SOCCER CLUB FOR A TERM OF ONE (1) YEAR; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

**WHEREAS**, On December 2<sup>nd</sup>, 2016, Request for Proposals #2016-40, "Youth Soccer Program Management" (the "RFP"), was advertised for the provision youth soccer program management services; and

**WHEREAS**, three (3) proposal submittals were received on January 27<sup>th</sup>, 2017 with both proposals meeting the required criteria; and

WHEREAS, an evaluation meeting was held on February 13<sup>th</sup>, 2017 where all submitted proposals were scored and ranked. A short-list of the top three (3) firms made presentations on February 21, 2017 and their presentations were scored and ranked. The evaluation committee determined that based on a Three Hundred (300) Point System with a possibility of Ten (10) extra points for: "Doral Based", "Miami-Dade/Broward County Based", "Certified Minority Business" or "Certified Veteran Business" the firms ranked as follows:

WHEREAS, Staff has recommended the approval to award Request for Proposals #2016-40 "Youth Soccer Program Management" to the top ranked firm and authorize the City Manager to negotiate and enter into an agreement with Doral Soccer Club for the

provision of providing youth soccer program management services for a period of one (1) year with a revenue split of 80% (Doral Soccer Club) and 20% (City of Doral).

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

<u>Section 2.</u> <u>Award.</u> Request for Proposals #2016-40 for the provision of youth soccer program management services is hereby awarded to Doral Soccer Club. This award does not create or confer any rights to Doral Soccer Club or any of the other ranked firms.

Section 3. Authorization to Procure Services. The City Manager is hereby authorized to negotiate and enter into an agreement with Doral Soccer Club for the provision youth soccer program management services for a period of one (1) year. The agreement is subject to approval by the City Attorney as to form and legal sufficiency and on such other terms and conditions as may be appropriate to protect and further the interests of the City. If the City Manager is not able to enter into an agreement with the top ranked firm, he is hereby authorized to negotiate with the next highest ranked firm successively until an agreement is reached.

<u>Section 4.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This resolution shall take effect immediately upon adoption.
