Dear Ms. Menendez:

In the past, the accounting transactions of Parks & Police 4 Kids, Inc. (the Organization), were recorded in a spreadsheet, in lieu of an accounting software program. Although spreadsheets are widely used for various functions in accounting and finance, it is not a recommended alternative to an accounting software program to process the accounting transactions. This process was changed and the Organization has implemented the use of an accounting software program. A significant part of using any software package is an understanding of the functionality and the various features that are offered by the program.

You have requested that I perform additional nonattest service for the Organization. The scope of the nonattest service requested is as follows;

Provide training to the support personnel that are currently in-charge of processing the transactions for the Organization. The purpose is to enhance the personnel use of the program and its functionality to record and process the transactions as well as prepare various reports that will be useful to management.

The training section will be provided at your office at a mutually convenient date and time.

You have requested that I provide you with an estimate of the fees for the training section. The service will be provided based on my standard billing rate of \$150.00 an hour and the reimbursement of any expenses incurred. I am estimating that the training section will take between four and half to five and half an hour.
