A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA ESTABLISHING A MILLAGE RATE OF 2.447 MILLS TO BALANCE THE GENERAL FUND FOR FISCAL YEAR 2009-2010; ESTABLISHING THE ROLLED-BACK RATE TO BE 2.6567 MILLS; AND ESTABLISHING TUESDAY, SEPTEMBER 22, 2009 AS THE DATE THAT A FINAL PUBLIC HEARING WILL BE HELD AT 6:00 P.M. AT THE CITY OF DORAL, CITY HALL COUNCIL CHAMBERS, 8300 NW 53RD STREET, SUITE 100, DORAL FLORIDA 33166; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City Council of the City of Doral establishes, pursuant to State law, a millage rate to balance the budget for the General Fund for Fiscal Year 2009-2010; and

WHEREAS, in furtherance of State law the City has confirmed its rolled-back rate and established a time and place for a public hearing on the City's millage rate and budget; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA:

Section 1. That the City Council establishes a millage rate of \$2.447 per \$1,000.00 of assessed property value within the City of Doral, to balance the budget for the General Fund for Fiscal Year 2009-2010 and establishes Tuesday, September 22, 2009 at 6:00pm, as the date and time of a final public hearing when the City Council will receive comments from the citizenry regarding the proposed budget and proposed millage rate.

Section 2. That the City Council further confirms the rolled-back rate for the 2009-2010 Fiscal Year to be 2.6567 mills and the millage rate is 2.447 mills which is 8% less than the rolled back rate.

Section 3. That the City Council further establishes the place and time of said public hearing to be the City of Doral, City Hall Council Chambers, located at 8300 N.W. 53rd Street, Doral, FL 33166 at 6:00 P.M..
