A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA RATIFYING THE RENEWAL OF THE ADOPT-A-STREET LITTER REMOVAL AGREEMENT WITH DHL EXPRESS (USA) FOR THE PROVISION OF LITTER-REMOVAL ACTIVITIES ALONG N.W. 18TH TERRACE FROM N.W. 87TH AVENUE TO N.W. 89TH PLACE AND N.W. 89TH PLACE FROM N.W. 18TH TERRACE TO N.W. 25TH STREET AND N.W. 24TH STREET BETWEEN N.W. 89TH PLACE AND THEORETICAL N.W. 88TH COURT; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral through Resolution No. 05-12 established an "Adopt-A-Street" Program permitting local organizations, private corporations and volunteer groups to beautify City-maintained roads through litter-removal activities and landscaping efforts; and

WHEREAS, DHL Express (USA) wishes to renew their adoption agreement for the removal of litter along N.W. 18th Terrace from N.W. 87th Avenue to N.W. 89th Place and N.W. 89th Place from N.W. 18th Terrace to N.W. 25th street and N.W. 24th Street between N.W. 89th Place and theoretical N.W. 88th Court; and

WHEREAS, Staff respectfully requests that the City Council ratify the renewal of the Adopt-A-Street Program Litter Removal Agreement with DHL Express (USA) for the provision of litter-removal services along N.W. 18th Terrace from N.W. 87th Avenue to N.W. 89th Place and N.W. 89th Place from N.W. 18th Terrace to N.W. 25th Street and N.W. 24th Street between N.W. 89th Place and theoretical N.W. 88th Court.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

Section 2. Ratification.
