

RESOLUTION No. 19-143

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING/DENYING THE MUSCULAR DYSTROPHY ASSOCIATION (MDA) REQUEST FOR A WAIVER OF THE OUTDOOR EVENT FEES IN THE AMOUNT OF \$1,630.70; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Muscular Dystrophy Association (the “Applicant”) is the sponsor of the Annual MDA Muscle Walk of Miami event to be held at Doral Central Park on October 12, 2019; and

WHEREAS, the Applicant requests that the Mayor and City Council of the City of Doral waive the Outdoor Event Fees in the amount of \$1,630.70 in exchange for recognition at the Muscle Walk event and promotion on social media sites; and

WHEREAS, the Mayor and City Council of the City of Doral find this proposal in the best interest of the City.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

Section 2. Approval. The Mayor and City Council of the City of Doral hereby approve/deny the Applicant’s request to have the Outdoor Event Fees in the amount of \$1,630.70 be waived as indicated in Exhibit A.

Section 3. Effective Date. This Resolution shall take effect immediately upon adoption.
