The performance of services associated with this Work Order will be executed on a time and material basis not to exceed the amount of \$23,438.00.

You are required by the Continuing Service Agreement to begin work subsequent to the execution of this Work Order, or as directed otherwise. If you fail to begin work subsequent to the execution of this Work Order, the City of Doral will be entitled to disqualify the Proposal and revoke the award.

Work Order incorporates the terms and conditions set forth in the Continuing Services Agreement dated January 4, 2021 between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply. Work Order is not binding until the City of Doral agrees and approves this Work Order.

CONSULTANT WORK ORDER PROPOSAL

Dear Mr. Quintero:

Gannet Fleming, Inc. (the Consultant) proposes to provide the services identified below for the project entitled "Chiller Plant Upgrade for Doral Legacy Park Recreation Building", pursuant to its Professional Service Agreement with the City of Doral (City), RFQ No. 2020-22.

I. SCOPE OF WORK

This proposal is based on preliminary discussions with you during our site visit on August 15, 2021. Please note that Gannett Fleming's engineering staff has significant experience with cooling plant upgrade projects. The project consists of providing design services for a chiller plant upgrade to provide piping system modifications to the existing chilled water distribution mains to allow for the connection of a temporary chiller in the event of chiller maintenance or chiller failure. An electrical design modification will be provided to allow for an electrical tie-in for the temporary chiller. This can be presented as a construction design alternate in the event the City of Doral plans to contract with a temporary chiller provider that will include a generator/chiller combination that does not require on-site building power. The design intent is to tie into existing power junction box at exterior chiller and extend conductors in overhead conduit to a manual transfer switch and temporary generator connection.

The scope of work (the Work) comprises the following tasks.

- Task 1: Preliminary Design Services (Work completed as of 8/15/2021)
 - Review of existing design documentation provided by City of Doral
- Task 2: Design Phase Services (Mechanical/Electrical)
 - Develop architectural backgrounds for the existing air-cooled chiller plant using the existing documentation, aerial images and photos taken during the site visit.
 - Prepare mechanical demolition and new work design documents to provide a tie-in to the existing chilled water piping mains.
 - Prepare electrical demolition and new work design documents to provide tie-in to the existing electrical system.
 - Specifications incorporated on the design drawings.
 - Provide a preliminary estimate of probable cost for review.
 - Provide pre-final design documents for review by City of Doral.
 - Review meeting with the City of Doral to address any review comments (Virtual Meeting).
 - Coordinate with City of Doral to assist in the final Bid Package preparation.
- Task 3: Bid Phase Services (Mechanical/Electrical)

- Pre-Bid Meeting with contractors to address any questions (Virtual Meeting).
- Respond to 2 RFI's during bid phase.
- Task 4: Construction Phase Services
 - Respond to RFI's during construction phase.
 - Shop Drawing review of the proposed equipment and components.
 - Record Drawings (electronic) using contractor's mark-ups.
- Task 5: QAQC
 - Attend one day of start up testing and document the results to affirm that work performed meets design requirements including issuance of an EOR Compliance Letter at completion of project. The Consultant shall be responsible for ensuring that their work products conform to appropriate standards and criteria. This shall be accomplished through an internal Quality Control (QC) process performed by the Consultant. This QC process shall ensure that quality is achieved through checking, reviewing, and surveillance of work activities by objective and qualified individuals who were not directly responsible for performing the initial work

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A WORK ORDER WITH GANNETT FLEMING, INC., TO PROCEED WITH ENGINEERING CONSULTING SERVICES FOR THE PROVISION OF THE CHILLER PLANT UPGRADE AT DORAL LEGACY PARK IN AN AMOUNT NOT TO EXCEED \$23,438.00; AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND AVAILABLE FUNDS ON BEHALF OF THE CITY IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, opened in August 2017, Doral Legacy Park is conceived as a place in which the Doral community can gather to enjoy sports, cultural arts, and recreational programming in a safe environment that is representative of the beautiful City of Doral. The facility offers several amenities for public use with one of the most popular amenities being the community center which includes indoor basketball courts, dance room, teen room, indoor play area, multi-purpose rooms, and an event hall; and

WHEREAS, the HVAC system for the community center is served by a Air-Cooled Chiller which services the 1st and 2nd floors of the community center including all the rooms and event hall; and

WHEREAS, in order to prevent any impact to services and use of the indoor spaces of the community center during period(s) when the chiller is offline for an extended period, the Parks & Recreation Department is requesting to incorporate a temporary chiller connection in which a temporary chiller unit can be brought in and connected to the existing HVAC infrastructure in order to be able to provide cool air to the community center; and

WHEREAS, for the development of the design and engineering documents required to install a temporary connection, the Parks & Recreation Department worked with the Public Works Department to identify a qualified firm through the City's pre-qualified pool of

Engineering and Architecture firms; and

WHEREAS, Gannett Fleming, Inc., is a prequalified provider of professional engineering consulting services selected in accordance with Consultant Competitive Negotiation Act (CCNA) requirements and approved by the City Council in December 2020; and

WHEREAS, Gannett Fleming, Inc. prepared a proposal for the development of design and engineering documents in a not to exceed amount of \$23,438.00; and

WHEREAS, staff recommends that the City Council approve and authorize the City Manager to execute the Work Order with Gannett Fleming, Inc. to develop design and engineering documents needed for the installation of a temporary chiller connection in an amount not to exceed of \$23,438.00; and

WHEREAS, funding for this request is available in the Parks & Recreation Account No. 102.90005.500634.
