

RESOLUTION No. 08 – 124

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AMENDING RESOLUTION 08-28 TO INCLUDE A MODIFICATION OF THE PERMIT APPLICATION PACKAGES FOR THE PROVISION OF COMPLETING N.W. 112TH AVENUE AND 114TH AVENUE FROM THEORETICAL N.W. 80TH STREET TO N.W. 81ST STREET IN AN AMOUNT NOT TO EXCEED \$7,947.37; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral seeks to improve traffic in the City by completing accessibility along N.W. 112th Avenue and 114th Avenue; and

WHEREAS, to complete this work, Resolution #08-28 authorized a contract with URS Corporation to assist with the mitigation and environmental permits needed for the wetland areas; and

WHEREAS, modifications to the federal, state and county environmental permits need to be made for the roadway improvements along N.W. 112th Avenue; and

WHEREAS, Staff respectfully requests that the City Council amend Resolution #08-28 to include a modification of the permit application packages for the provision of completing N.W. 112th Avenue and 114th Avenue from theoretical N.W. 80th Street to N.W. 81st Street in an amount not to exceed \$7,947.37.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. The City Council of the City of Doral hereby amends Resolution #08-28 to include a modification of the permit application packages for the provision of completing N.W. 112th Avenue and 114th Avenue from theoretical N.W. 80th Street to N.W. 81st Street in an amount not to exceed \$7,947.37.

Section 2. This Resolution shall take effect immediately upon adoption.


