## **RESOLUTION No. 08 – 124**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AMENDING RESOLUTION 08-28 TO INCLUDE A MODIFICATION OF THE PERMIT APPLICATION PACKAGES FOR THE PROVISION OF COMPLETING N.W. 112<sup>TH</sup> AVENUE AND 114<sup>TH</sup> AVENUE FROM THEORETICAL N.W. 80<sup>TH</sup> STREET TO N.W. 81<sup>ST</sup> STREET IN AN AMOUNT NOT TO EXCEED \$7,947.37; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral seeks to improve traffic in the City by completing accessibility along N.W. 112<sup>th</sup> Avenue and 114<sup>th</sup> Avenue; and

WHEREAS, to complete this work, Resolution #08-28 authorized a contract with URS Corporation to assist with the mitigation and environmental permits needed for the wetland areas; and

WHEREAS, modifications to the federal, state and county environmental permits need to be made for the roadway improvements along N.W. 112<sup>th</sup> Avenue; and

**WHEREAS,** Staff respectfully requests that the City Council amend Resolution #08-28 to include a modification of the permit application packages for the provision of completing N.W. 112<sup>th</sup> Avenue and 114<sup>th</sup> Avenue from theoretical N.W. 80<sup>th</sup> Street to N.W. 81<sup>st</sup> Street in an amount not to exceed \$7,947.37.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. The City Council of the City of Doral hereby amends Resolution #08-28 to include a modification of the permit application packages for the provision of completing N.W. 112<sup>th</sup> Avenue and 114<sup>th</sup> Avenue from theoretical N.W. 80<sup>th</sup> Street to N.W. 81<sup>st</sup> Street in an amount not to exceed \$7,947.37.

Section 2. This Resolution shall take effect immediately upon adoption.
