

RESOLUTION No. 17-51

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, ACCEPTING AN EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT (JAG) AWARD FROM FLORIDA DEPARTMENT OF LAW ENFORCEMENT (FDLE) IN THE AMOUNT OF \$6,687.00 FOR THE PURCHASE OF POLICE TRAINING DUMMIES FOR THE PURPOSE OF IMPROVING THE LEARNING AND USE OF PUBLIC SAFETY TECHNIQUES; AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH THE FLORIDA DEPARTMENT OF LAW ENFORCEMENT AND RECEIVE THE GRANT; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in December 12, 2016, the City of Doral Police Department (the “City”) applied for an Edward Byrne Memorial Justice Assistance Grant from the Florida Department of Law Enforcement for the purchase of police training dummies for the purpose of enhancing the learning and use of public safety techniques; and

WHEREAS, in February 20nd, 2017, the City was notified that the Grant has been awarded, subject to the entering of an agreement with FDLE, attached hereto as Exhibit “A” (the “Agreement”), which is incorporated herein and made a part hereof by this reference; and

WHEREAS, staff has recommended that Mayor and City Council accept the Grant in the amount of \$6,687.00 for the purpose of enhancing the learning and use of public safety techniques and authorize the City Manager to execute the Agreement in furtherance hereof.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval. The Mayor and City Council, on behalf of the City of Doral, hereby accepts an Edward Byrne Memorial Justice Assistance Grant Award from Florida Department of Law Enforcement in the amount of \$6,687.00 to be funded from

account 001.60005.500642 for the purchase of police training dummies for the purpose of enhancing the learning and use of public safety techniques.

Section 3. Implementation. The City Manager and City Attorney are hereby authorized to take such additional action as may be necessary to implement the purpose and provision of this Resolution.

Section 4. Effective Date. This Resolution shall become effective immediately upon its adoption.
