A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A WORK ORDER WITH MARLIN ENGINEERING, INC. FOR THE PROVISION OF DESIGN AND PERMITTING SERVICES FOR THE CITYWIDE SIDEWALK IMPROVEMENTS PHASE III PROJECT, IN AN AMOUNT NOT TO EXCEED \$100,297.00; RECOGNIZING THAT MARLIN ENGINEERING, INC. IS A CITY OF DORAL PREQUALIFIED VENDOR; AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral ("City") Public Works Department (PWD) is in need of a firm to provide design services for the Citywide Sidewalk Improvements Phase III Project as a continuation to the completed Phase II project; and

WHEREAS, the PWD requested a proposal from Marlin Engineering, Inc. ("Marlin") to perform the design and permitting phase for the Citywide Sidewalk Improvements Phase III improvements to provide continuity to both Phase I and Phase II; and

WHEREAS, Marlin is a pre-qualified provider of professional engineering services selected in accordance with Consultant Competitive Negotiation Act (CCNA) requirements and approved by the City Council in December 2020 via Resolution No. 20-243; and

**WHEREAS,** PWD staff and Marlin negotiated the attached proposal in a not to exceed amount of \$100,297.00; and

WHEREAS, Marlin will develop the design plans and obtain all necessary permits and approvals for the project to move forward into construction phase; and

WHEREAS, the design services include topographical survey, utility coordination, development of construction plans, permitting with regulatory agencies, and other tasks as detailed in Marlin's proposal; and

WHEREAS, City staff respectfully requests that the City Council approve Work Order No. 13 with Marlin, a copy of which is attached hereto as Exhibit "A", for the provision of design and permitting services for the Citywide Sidewalks Improvements Phase III Project in an amount not to exceed \$100,297.00; and

WHEREAS, funding for this request is available for Transportation Fund, Account Num. 101.80005.500650

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

**Section 4. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

This Work Order incorporates the terms and conditions set forth in the Professional Services Agreement dated January 4, 2021, between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply. This Work Order is not binding until the City of Doral agrees and approves this Work Order.
