## RESOLUTION NO. 11-112

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL. FLORIDA. APPROVING AMENDMENT NO. TWO TO LEASE NO. 4602 WITH THE BOARD OF TRUSTEES OF THE INTERNAL IMPROVEMENT TRUST FUND OF STATE OF THE FLORIDA; AUTHORIZING THE CITY MANAGER TO ENTER INTO AMENDMENT NO. TWO; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on December 23, 2008, the City of Doral (the "City") entered into a Lease with the Board of Trustees of the Internal Improvement Trust Fund of the State of Florida (the "State") to lease approximately five acres of land located in the City for the purpose of a Police Facility ("Lease No 4602"); and

WHEREAS, on August 18, 2010, the City entered into Amendment No. One to Lease No. 4602 with the State, amending Lease No. 4602 to add some additional property to the terms of Lease No. 4602; and

WHEREAS, Lease No. 4602 currently requires the City to commence construction of the police facility not later than December 23, 2011, and the City Council desires for the City to have additional time to commence and complete construction; and

WHEREAS, the State is willing to amend Lease No. 4602 to extend the mandatory commencement of construction until not later than August 18, 2013, without changing any other terms of Lease No. 4602.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a part of this Resolution upon adoption hereof.

<u>Section 2.</u> The City Council hereby approves Amendment No. Two to Lease No. 4602 with the Board of Trustees of the Internal Improvement Trust Fund of the State of Florida, substantially in the form of Exhibit A hereto, and further authorizes the City Manager to execute the agreement on behalf of the City.

**Section 3.** This Resolution shall take effect immediately upon adoption.
