

**RESOLUTION No. 20-19**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO TRANSFER DONATED PROPERTY FROM BENQ TO NON-PROFIT ORGANIZATIONS LOCATED IN DORAL; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, BenQ is a Taiwanese Multinational for profit company that sells and markets technology products, consumer electronics, computing and communications devices whose Latin American Office is located in Doral, and

**WHEREAS**, BenQ's main office is located in Taipei, and the company operates five branch offices in the Asia-Pacific, Europe, China Latin America and employs over 1,300 individuals; and

**WHEREAS**, BenQ's Doral Office recently donated projectors to the City of Doral for that equipment to be further donated to local non-profits within the City of Doral; and

**WHEREAS**, the City of Doral has identified four non-profits that operate within the limits of the City of Doral and have agreed to accept the donation; and

**WHEREAS**, the non-profits are Iglesias Dios con Nostros, Doral Troop 552, DORCAM and Our Lady of Guadalupe Catholic Church; and

**WHEREAS**, the City Manager's Office respectfully requests authorization from the Mayor and City Councilmembers to transfer the donated items to the identified non-profits organizations located in Doral; and

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The foregoing recitals are confirmed, adopted and incorporated herein and made a part hereof by this reference.

**Section 2. Authorization.** The City Manager is hereby authorized to transfer the five (5) donated projectors to the identified Non-Profit Organizations located in Doral.

**Section 3. Implementation.** The City Manager is authorized to take such action as may be necessary to implement the provisions of this resolution.

**Section 4. Effective Date.** This Resolution shall become effective immediately upon its adoption.

The foregoing Resolution was offered by Councilmember Mariaca who moved its adoption. The motion was seconded by Councilmember Cabral and upon being put to a vote, the vote was as follows:
