## **RESOLUTION No. 24-47**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT REQUESTED BY CICI AVELAR ON BEHALF OF PAR 5 GROUP, TO HOST THE "LIV GOLF INVITATIONAL - MIAMI @ TRUMP NATIONAL DORAL" TO BE HELD AT TRUMP NATIONAL DORAL, LOCATED AT 4400 NW 87 AVENUE, DORAL, FL 33178 FROM FRIDAY, APRIL 5, 2024 TO SUNDAY, APRIL 7, 2024 FROM 9:00 AM TO 9:00 PM; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Cici Avelar (the "Applicant") seeks approval from the City of Doral for a special event permit to host the "LIV Golf Invitational - Miami @ Trump National Doral" to be held at 4400 NW 87 Avenue; and

WHEREAS, the City Manager recommends that the Mayor & City Council approve the proposed special event permit to host the "LIV Golf Invitational – Miami @ Trump National Doral" from Friday, April 5, 2024, to Sunday, April 7, 2024, at Trump National Doral, located at 4400 NW 87 Avenue, Doral, FL 33178, from 9:00 a.m. to 9:00 p.m.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made as part hereof by this reference.

<u>Section 2. Approval.</u> The special event permit for the "LIV Golf Invitational-Miami@ Trump National Doral" is hereby approved subject to the following conditions:

- 1. The Applicant shall secure all necessary and required building, electrical, plumbing, or other permits, and shall immediately furnish proof of such permits upon request from the city.
- 2. The Applicant shall be required to have all inspections and approvals at least three (3) working days prior to the event date.

- 3. Sanitary facilities shall be provided by the Applicant and shall be of the type and in a sufficient number as to meet the requirements established by the Building Department.
- 4. The Applicant is responsible for providing adequate security at the special event. The police department shall require the Applicant to provide and pay for security personnel for crowd control and traffic direction purposes. The County's Fire Rescue Department may require the Applicant to provide and pay for fire watch personnel.
- 5. The Applicant shall comply with the comments made by the City of Doral Police Department and pay all applicable fees no later than fourteen (14) days in advance of the event.
- 6. The Applicant shall provide to the City of Doral an acceptable certificate of insurance naming the city as an additional insured three (3) weeks prior to the event date.
- 7. The Applicant shall secure a maintenance of traffic (MOT) permit from the City of Doral Public Works Department and/or Miami-Dade County Department of Transportation and Public Works seven (7) working days prior to event start date.
- 8. The Applicant shall be responsible for providing sufficient parking to meet the event parking requirements. In addition, the Applicant shall provide the Planning and Zoning Department a copy of the parking agreements with the entities mentioned in the staff report to accommodate overflow parking. These agreements shall be provided no later than fifteen (15) days prior to the event's start date.

<u>Section 3.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon its adoption.
