

RESOLUTION No. 11 – 58

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE AWARD OF A COMMUNITY BASED ORGANIZATION GRANT OF \$5,000.00 EACH TO BISON BAND BOOSTER; MIAMI FOREIGN TRADE ASSOCIATION, INC.; AMERICAN CANCER SOCIETY, RELAY FOR LIFE DORAL; CHINESE SCHOOL OF DORAL; SER-JOBS FOR PROGRESS; AND BOY SCOUTS TROOP 552; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral received ten (10) applications for the second cycle of FY 2011 Community Based Organization (CBO) grants by the March 21, 2011 deadline; and

WHEREAS, upon review of the applications submitted, Staff respectfully requests that the City council authorize a CBO grant in the amount of \$5,000.00 each to the following organizations:

1. Bison Band Booster
2. Miami Foreign Trade Association, Inc.
3. American Cancer Society, Relay for Life of Doral
4. Chinese School of Doral
5. SER-Jobs for Progress
6. Boy Scouts Troop 552

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. The aforementioned recitals are true and correct.

Section 2. The City Council hereby authorizes a CBO grant award in the amount of \$5,000.00 each to Bison Band Booster; Miami Foreign Trade Association, Inc.; American Cancer Society, Relay for Life of Doral; Chinese School of Doral; SER-Jobs for Progress; and Boy Scouts Troop 552.

Section 3. This Resolution shall take effect immediately upon adoption.
