SCOPE OF SERVICES AND SCEHDULE:

The scope of the project will be as described in the attached proposal from The Corradino Group dated July 29, 2022. The schedule requires the scoped of work to be completed within 120 calendar days of NTP. All limitations of time set forth in this Work Order are of the essence. The performance of services associated with this Work Order will be executed on a time and material basis not to exceed the amount of \$72,960.00.

You are required by the Continuing Service Agreement to begin work subsequent to the execution of this Work Order, or as directed otherwise. If you fail to begin work subsequent to the execution of this Work Order, the City of Doral will be entitled to disqualify the Proposal and revoke the award.

Work Order incorporates the terms and conditions set forth in the Continuing Services Agreement dated January 1, 2020 between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply. Work Order is not binding until the City of Doral agrees and approves this Work Order.

WHEREAS, on May 12, 2021, the 2021 Stormwater Master Plan and the proposed 5-Year Capital Improvement Plan (CIP) was adopted by the City Council via Resolution No. 21-123 (approved 5-0); and

WHEREAS, the results of the Stormwater Master Plan analysis allowed the City to identify and prioritize general areas where major drainage systems are deficient and defined the extent of the deficiencies; and

WHEREAS, the PWD requested a proposal from The Corradino Group, Inc. to provide Construction Engineering Inspection (CEI) Services for ITB 2022-23 Sub Basin NW 33 ST W stormwater improvement project, a portion of Year 1 of the Stormwater Improvements CIP; and

WHEREAS, Sub Basin NW 33 ST W is located along NW 33rd Street between NW 87th Avenue and NW 82nd Avenue; and

WHEREAS, The Corradino Group, Inc. is a prequalified provider of professional engineering services selected in accordance with Consultant Competitive Negotiation Act (CCNA) requirements and approved by the City Council in the December 2020 via Resolution 20-243; and

WHEREAS, the work should be performed in accordance with the contract provisions contained in the Continuing Professional Services Agreement between The Corradino Group, Inc. and the City of Doral dated January 4, 2021, and the attached Proposal dated July 29, 2022; and

WHEREAS, staff respectfully requests to execute Work Order No. 3 to The Corradino Group, Inc. to provide Construction Engineering Inspection (CEI) Services for

ITB 2022-23 Sub Basin NW 33 ST W stormwater improvement project in an amount not to exceed \$72,960.00, a copy of which is attached as Exhibit "A"; and

WHEREAS, funding for this request is available in the current Fiscal Year in the Public Works Stormwater Fund – "Construction in Progress" Account, Account No. 401.80005.500650.

Dear Ms. Bortz:

The Corradino Group proposes to provide Construction Engineering Inspection Services to the City of Doral NW 33rd Street Drainage Improvement from NW 87th Ave to NW 82nd Ave. The Scope of Services provided will be in agreement with the Work Order Tasks identified below:

- A. Task 1 Monitor Contractor implementation and compliance with MOT plans
 - a. Review Safety Plans and MOT plans for Compliance
 - b. Work Day review of MOT set up.
- B. Task 2 Monitor drainage including pipe, manholes and outfall installation by Contractor
- C. Task 3 Monitor roadway stabilization, base, asphalt, and pavement markings installation by Contractor
- D. Task 4 Monitor miscellaneous construction activities by Contractor
 - a. Oversight of clearing and grubbing including ay required demolition
 - b. Oversight of erosion and sedimentation control measures
- E. Task 5 Monitor other relevant tasks such as grading, curb and gutter, guardrail, fence, and sod installation by Contractor
- F. Task 6 Provide weekly updates, logging RFIs and Shop Drawings that are submitted, Project Meetings.

The construction phase services assume the construction project to be completed in 120 calendar days, if construction needed to occur in more than 120 calendar days, additional services will be required. The Corradino Group during this construction phase will provide a Project Manager/Administrator and Construction Inspector to coordinate with City, project's Contractor, EOR and provide construction phase services specifically stated below:

- 1. CEI Project Administrator will oversee the Inspector, and review and approve the daily report of construction on a daily basis.
- 2. CEI Project Administrator will prepare and submit to the City a weekly progress report of all work activities the Monday following the week worked.
- 3. CEI Project Administrator will review and approve the pay applications made by the contractor.
- 4. CEI Project Administrator will submit a letter to the City approving the pay application for payment;
- 5. CEI Project Administrator will work closely with the Contractor/EOR/City's Project Manager to resolve field issues/RFI's in a timely manner. CEI will receive shop drawing materials, coordinate with Engineer of Record and City, and monitor shop drawing review. Approval process will be provided by the Engineer of Record. CEI will maintain a Shop Drawings Log.
- 6. CEI Project Administrator will review Safety and MOT Plans submitted by the contractor to the City for compliance and conformance with the contract.
- 7. CEI Project Administrator will ensure that erosion and sedimentation control plan is in place prior to start construction activities.

- 8. CEI Inspector will oversee the contractor's daily construction activities making sure that all work complies with the plans and specifications.
- 9. CEI Inspector will document all construction activities in a daily report of construction.
- 10. CEI Inspector will verify that the approved MOT setup meets contract and MUTCD requirements.
- 11. CEI Inspector will monitor the drainage installation activities, including pipe alignment, pipe and structures elevations, installation of French Drain including filter fabric and ballast rock.
- 12. CEI Inspector will verify the contractor's material (earthwork and concrete) samples test results for conformance with the contract
- 13. CEI Inspector will verify that the earthwork, concrete, asphalt and other materials incorporated into the project are in compliance with the plans and specs and that both concrete and asphalt materials incorporated in the project are from approved plants and approved design mixes.
- 14. CEI Inspector will maintain an as-built record set for submittal to the City upon project completion.
- 15. CEI Inspector will have all required CTQP qualifications/MOT certifications for the tasks assigned to him.
- 16. CEI Inspector will verify that the contractor is adhering to OSHA guidelines.
