

RESOLUTION No. 19-58

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY CODE OF ORDINANCES, APPROVING THE PURCHASE OF CISCO NETWORK EQUIPMENT FOR DORAL GLADES PARK FROM IT SAVVY LLC, VIA CISCO GSA CONTRACT NO. GS-35F-0563UVIA, IN AN AMOUNT NOT TO EXCEED \$58,316.81; AUTHORIZING THE CITY MANAGER TO EXECUTE CONTRACTUAL DOCUMENTS AND EXPEND BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Doral Glades Park is a new City facility that provides a solution for training, special events, classrooms, and exhibit room; and

WHEREAS, this expansion of the citywide network infrastructure is based on Cisco network equipment. Cisco is a global reputable manufacturer who dedicates itself in selling network equipment, support, and maintenance through competitive resellers; and

WHEREAS, section 2-322 of the City Code of Ordinances provides that the City may enter into contracts competitively entered into by other governmental entities; and

WHEREAS, The Information Technology Department sought to acquire the best feasible competitive quotes for the purchase of two (2) Cisco Catalyst 3850 network switches and seventeen (17) Cisco Meraki wireless access points as mentioned above. The best offer came from IT Savvy LLC., for \$58,316.81 which is based on Cisco GSA: GS-35F-0563U; and

WHEREAS, These contracts were competitively entered into in a manner like that set forth in Chapter 2, Article V, of the City Code, provides that the City may enter into contracts competitively entered into by other governmental entities; and vendor participating in State of Florida Contract. Attached please find "Exhibit A" which includes

four (4) quotes from PC Solutions & Integration, Inc., ITsavvy, UDT, and CDW, and a copy of the Cisco GSA: GS-35F-0563U and Cisco State of Florida Contract #4322000-WSCA-14ACS; and

WHEREAS, The Information Technology Department request that the Mayor and City Council members approve purchase of two (2) Cisco Catalyst 3850 network switches and seventeen (17) Cisco Meraki wireless access points to expand our current Cisco network infrastructure to the new Doral Glades Park facility. Funds have been allocated in Account#: 102.22005.500652

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval. Pursuant to section 2-322 of the City Code of Ordinances, the procurement of the Cisco Network Equipment from IT Savvy LLC. via Cisco GSA: GS-35F-0563U in accordance with its quote in Exhibit "A", in an amount not to exceed **\$58,316.81**, is hereby approved.

Section 3. Authorization. The City Manager is hereby authorized to enter into an agreement and other contractual documents, subject to approval as to form and legal sufficiency by the City Attorney, as may be necessary to procure the Cisco Network Equipment, and to expend funds in furtherance hereof.

Section 4. Implementation. The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Vice Mayor Mariaca who moved its adoption.
