A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT REQUESTED BY CLASICA MASTER 300 KM CORP., TO HOST THE "GRAN FONDO CYCLING CHALLENGE MIAMI" AS FOLLOWS: ON FRIDAY NOVEMBER 16, 2024 WELCOME, ORIENTATION AND REGISTRATION PACKAGES DISTRIBUTION AT DORAL CULTURAL CENTER LOCATED AT 8363 NW 53 STREET, DORAL, FL 33166 FROM 8:00 A.M. TO 6:00 P.M.; AND ON SATURDAY, NOVEMBER 17, 2024 THE RACE WILL START AT 7:30 AM AND FINISH AT APPROXIMATELY 3:30 PM AT DOWNTOWN DORAL PARK LOCATED AT 8395 NW 53 STREET DORAL, FL, 33166; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, CLASICA MASTER 300 KM CORP., (the "Applicant") seeks approval from the City of Doral of a special event permit to host the "Gran Fondo Cycling Challenge Miami"; and

WHEREAS, the purpose of the event is to promote the social and health benefits through cycling and family activities; and

WHEREAS, the City Manager recommends that the Mayor and City Council approve the proposed special event permit to host the "Gran Fondo Cycling Challenge Miami" at Doral Cultural Center on Friday, November 16, 2024 from 8:00 a.m. to 6:00 p.m. and Saturday, November 17, 2024, at Downtown Doral Park located at 8395 NW 53 Street, Doral, FL, from 5:00 am. to 5:00 p.m. and the Gran Fondo Cycling Challenge Miami race at Downtown Doral Park located at 8395 NW 53 Street, Doral , FL. 33166 from 7:30 a.m. to 3:30 p. m.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

**Section 1.** Recitals. The above recitals are true and correct and incorporated herein.

<u>Section 2.</u> Approval. The special event permit for the "Gran Fondo Cycling Challenge Miami"; is hereby approved subject to the following conditions:

- 1. The Applicant shall secure all necessary and required building, electrical, plumbing, or other permits, and shall immediately furnish proof of such permits upon request from the city.
- 2. The Applicant shall be required to have all inspections and approvals prior to the event date.
- Sanitary facilities shall be provided by the Applicant and shall be of the type and in a sufficient number as to meet the requirements established by the Building Department.
- 4. The Applicant is responsible for providing adequate security at the special event. The police department may require the Applicant to provide and pay for security personnel for crowd control and traffic direction purposes. The county fire rescue department may require the Applicant to provide and pay for fire watch personnel.
- 5. The Applicant shall comply with comments made by the City of Doral Police Department and pay all applicable fees no later than 14 days in advance of the event.
- 6. The Applicant shall provide to the City of Doral an acceptable certificate of insurance four weeks prior to the event date.
- 7. The approval of this special event application is subject on having an approved MOT from the City of Doral Public Works Department, Miami-Dade County Department of Transportation and Public Works and other jurisdictions (if applicable) along the entire route of the event; and the parking agreement with Codina Partners within 30 days after the Mayor and City Council approval. The City Manager or his/her designee may extend the deadline if the Applicant has shown good faith effort toward obtaining the approval of the MOT and/or the parking agreement with Codina Partners.

<u>Section 3.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
