

**RESOLUTION No. 09 – 108**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA APPROVING THE AWARD OF A COMMUNITY BASED ORGANIZATION GRANT IN THE AMOUNT OF \$5,000.00 EACH TO DFYIT; HOSPICE CARE SOUTHEAST FLORIDA, INC.; BISON BAND BOOSTER, INC.; DORAL BUSINESS COUNCIL; AND TRANSPLANT FOUNDATION, INC.; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral received four (5) applications in response to the third round of Community Based Organization (CBO) Grant Applications for FY 08-09 by the July 9<sup>th</sup>, 2009 deadline; and

**WHEREAS**, on July 2<sup>nd</sup>, 2009, the review committee held a workshop to allow applicants the opportunity to ask questions about the application process; and

**WHEREAS**, after careful review of the applications, Staff respectfully recommends that the City Council approve a CBO award of \$5,000.00 to each of the following organizations:

1. DFYIT
2. Hospice Care Southeast Florida, Inc.
3. Bison Band Booster, Inc.
4. Doral Business Council
5. Transplant Foundation, Inc.

**NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1.** The City Council of the City of Doral hereby approves a CBO award of \$5,000.00 each to DFYIT; Hospice Care Southeast Florida, Inc.; Bison Band Booster, Inc.; the Doral Business Council; and the Transplant Foundation, Inc.
