A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO ENTER INTO A PARTNERSHIP WITH THE UNIVERSITY OF MIAMI TO PROVIDE THE PARENT CLUB TO DORAL RESIDENTS AND ASSIST WITH MARKETING THE PROGRAM TO THE COMMUNITY; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Representatives from the University of Miami reached out to the City to discuss the Parent Club and expressed interest in a possible partnership; and

WHEREAS, The Parent Club provides free workshops for parents of children ages 3-12 years old and connect caregivers to resources for additional professional assistance; and

WHEREAS, The Parent Club is funded through The Children's Trust and therefore offered at no cost to the participants or to the City; and

WHEREAS, The Parent Club and partnership ties in with the City's Step up your health, Doral! Wellness initiative providing educational resources with mental and emotional health components to residents; and

WHEREAS, Partnering with The University of Miami will allow Doral residents to participate and benefit from these workshops; and

WHEREAS, Staff respectfully requests approval from the Mayor and City Councilmembers to authorize the City to partner with The University of Miami to offer their Parent Club program as well as assist with marketing the program to Doral residents and the Doral Community.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

<u>Section 2.</u> Approval & Authorization. The Mayor and City Councilmembers hereby authorize the City Manager to enter into a partnership with the University of Miami to offer their Parent Club and assist with marketing the program to Doral residents.

Section 3. Implementation. The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

<u>Section 4.</u> <u>Effective Date.</u> This resolution shall take effect immediately upon adoption.
