

**RESOLUTION No. 18-82**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY CODE OF ORDINANCES, APPROVING THE PURCHASE AND RETROFITTING OF FOUR (4) UNMARKED POLICE VEHICLES IN AN AMOUNT NOT TO EXCEED \$106,752.00 VIA FLORIDA SHERIFF'S ASSOCIATION CONTRACT FSA17-VEH15.0; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT, SUBJECT TO APPROVAL AS TO FORM AND LEGAL SUFFICIENCY BY THE CITY ATTORNEY, FOR THE PURCHASE; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the Police Department for the City of Doral (the "City") seeks to purchase four (4) unmarked police vehicles from Prestige Ford; and

**WHEREAS**, keeping with the past replacement strategy goals, the City of Doral Police Department recommends the purchase of 2018 Ford Taurus SEL/AWD over the 2018 Chevrolet Impala LS. This recommendation is being made after contacting several police agencies who are currently utilizing the Ford Taurus without experiencing mechanical issues; and

**WHEREAS**, section 2-322 of the City Code of Ordinances authorizes the City to purchase good and services via the contracts of other governmental entities, provided that such contracts have been achieved in a competitive manner similar to those established in the City Code; and

**WHEREAS**, Staff recommends that the City Council authorize the City Manager to negotiate and enter into an agreement with Prestige Ford for the purchase of four (4) unmarked police vehicles in an amount not to exceed \$99,096.00 via Florida Sheriffs Association Contract FSA17-VEH15.0, which was competitively entered into in a manner similar to that set forth in Chapter 2, Article V of the City Code; and

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL  
OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1. Recitals.** The foregoing recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval.** Pursuant to section 2-322, the purchase of four (4) unmarked police vehicles from Prestige Ford, in an amount not to exceed \$99,096.00, via Florida Sheriffs Association Contract FSA17-VEH15.0, and retrofitting in an amount not to exceed \$7,656.00 for a total amount of \$106,752.00 is hereby approved. This purchase and retrofitting is funded from savings from the 2017-2018 FY Budget. Two (2) vehicles from account 001.60005.500641 Police Budget-Capital Outlay-Vehicles and two (2) vehicles from account 103.60005.500641 Impact Fees Capital Outlay.

**Section 3. Authorization.** The City Manager is hereby authorized to enter into an agreement and other contractual documents, subject to approval as to form and legal sufficiency by the City Attorney, as may be necessary to procure the Vehicles under the State of Florida contract with Prestige Ford, and to expend funds in furtherance thereof in amounts not to exceed \$99,096.00 and retrofitting in an amount not to exceed \$7,656.00 for a total amount of \$106,752.00.

**Section 4. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

**Section 5. Effective Date.** This Resolution shall become effective immediately upon its adoption.

The foregoing Resolution was offered by Vice Mayor Rodriguez who moved its adoption.
