

**RESOLUTION No.12-109**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA APPROVING AN OUTDOOR EVENT PERMIT FOR FEDEE MUNDIAL TO HOST THE ECUADOR GET TOGETHER AT JC BERMUDEZ PARK ON SATURDAY, OCTOBER 13, 2012 FROM 10:00 AM TO 6:00 PM ; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Fedee Mundial, (“Applicants”) seeks approval from the City of Doral for an Outdoor Event Permit; and

**WHEREAS**, Staff respectfully recommends that Council approve the proposed Outdoor Event Permit for Fedee Mundial to host the Ecuador Get Together on Saturday, October 13, 2011 from 10:00 am to 6:00 pm at JC Bermudez Park located at 3000 NW 87<sup>th</sup> Avenue subject to the following conditions:

1. All necessary rental, clean-up and staff fees, pursuant to the fee schedule attached, must be furnished to the Parks and Recreation Department prior to the event
2. Construction plans for tents and any outdoor structural facility must be submitted to the Building Department for approval and final inspection.
3. An agreement with the City of Doral Police must be established for off-duty police officers prior to the event
4. Hours of Operation limited from 10:00 am to 6:00 pm.

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1.** The foregoing recitals are incorporated herein.

**Section 2.** The City Council of the City of Doral, Florida hereby approves the

outdoor event permit for Fedee Mundial to host the Ecuador Get Together event subject to the conditions listed in the above "whereas" clause.

**Section 3.** This Resolution shall take effect immediately upon adoption.


