A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A WORK ORDER BETWEEN THE CITY OF DORAL AND KING ENGINEERING, A PREQUALIFIED VENDOR, FOR THE PROVISION OF CONSTRUCTION ENGINEERING INSPECTION SERVICES FOR THE STORMWATER IMPROVEMENTS PROJECT AT SUB BASIN H-8 OF THE STORMWATER MASTER PLAN, IN AN AMOUNT NOT TO EXCEED \$114,685.00; AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City"), by and through its Public Works Department, wishes to secure a firm to provide Construction Engineering Inspection services ("CEI Services") for the construction of stormwater improvements at Sub-Basin H-8 of the Stormwater Master Plan (the "Project"); and

WHEREAS, King Engineering (King) is a pre-qualified provider of professional engineering services for the City, selected in accordance with Consultant Competitive Negotiation Act requirements and approved by the City Council in December 2014; and

WHEREAS, City staff has recommended that the City Council approve Work Order No. 5 for King Engineering, a copy of which is attached hereto as Exhibit "A", which is incorporated herein and made a part hereof by this reference, for the provision of CEI Services for the construction of the Project in an amount not to exceed \$114,685.00.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

The City of Doral authorizes the firm of King Engineering Associates, Inc. to proceed with construction administration services (CEI) for stormwater improvements proposed as part of Sub Basin H-8 of the 5-Year Stormwater Improvements Capital Improvement Plan adopted in March 2015, as of the date of this Work Order. The work should be performed in accordance with the contract provisions contained in the Continuing Professional Services Final Agreement between King Engineering Associates, Inc. and the City of Doral dated February 9, 2015, and the attached Proposal submitted by your firm for the above referenced project.

SCOPE OF SERVICES AND SCEHDULE:

The scope of the project will be as described in the attached proposal from King Engineering Associates, Inc. dated June 13, 2016, which includes review of construction documents, MOT plans, project schedule, submittals, RFIs, change order proposals, construction activities (full time), density and compaction test reports, construction invoices, and as-built drawings. The schedule requires the work to be performed within two hundred and ten (210) calendar days from the notice to proceed. The performance of services associated with this Work Order will be executed on a time and material basis with a not to exceed amount of \$114,685.00.

You are required by the Continuing Service Agreement to begin work subsequent to the notice to proceed. If you fail to begin work subsequent to the Notice to proceed, the City of Doral will be entitled to disqualify the Proposal, and revoke the award.

This Work Order incorporates the terms and conditions set forth in the Continuing Services Agreement dated February 9, 2015 between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply.

Work Order is not binding until the City of Doral agrees and approves this Work Order.
