

**RESOLUTION No. 19-118**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AWARING REQUEST FOR PROPOSALS # 2019-13 “RECREATIONAL YOUTH SAND VOLLEYBALL PROGRAM MANAGEMENT” TO MIAMI VOLLEYBALL ACADEMY FOR THE PROVISION OF RECREATIONAL YOUTH SAND VOLLEYBALL PROGRAMMING; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH MIAMI VOLLEYBALL ACADEMY FOR A PERIOD OF ONE (1) YEAR WITH TWO (2) ADDITIONAL ONE (1) YEAR RENEWALS FOR A POSSIBLE TOTAL OF THREE (3) YEARS; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, On January 10, 2019, the City of Doral (the “City”) advertised Request for Proposals (“RFP”) # 2019-13 “Recreational Youth Sand Volleyball Program Management” for the provision of providing recreational youth sand volleyball programming for the Parks & Recreation Department; and

**WHEREAS**, One (1) firm attended the mandatory pre-bid meeting on March 27, 2019. One (1) submittal was received and opened on April 12, 2019, with that firm meeting the required criteria set forth in the RFP; and

**WHEREAS**, On April 26, 2019, the evaluation committee scored and ranked submittals based on a three-hundred point (300) scale. The ranking of firms is as follows...

**WHEREAS**, staff respectfully requests approval to award RFP #2019-13 “Recreational Youth Sand Volleyball Program Management” to the top ranked firm and authorize the City Manager to negotiate and enter into an agreement with Miami Volleyball Academy for the provision of providing recreational youth sand volleyball programming for

a period of one (1) year with two (2) additional one (1) year renewals for a possible total of three (3) years.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval & Authorization.** The City Council hereby approves the award of RFP # 2019-13 to the top ranked firm and authorizes the City Manager to negotiate and enter into an agreement with Miami Volleyball Academy for the provision of providing recreational youth sand volleyball programming for a period of one (1) year with two (2) additional one (1) year renewals for a possible total of three (3) years.

The agreement is subject to approval by the City Attorney as to form and legal sufficiency and on such other terms and conditions as may be appropriate to protect and further the interest of the City. This Authorization does not create or confer any rights to Miami Volleyball Academy.

**Section 3. Implementation.** The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

**Section 4. Effective Date.** This resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Vice Mayor Mariaca who moved its adoption. The motion was seconded by Councilmember Cabral and upon being put to a vote, the vote was as follows:
