

RESOLUTION NO. Z09-06

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA APPROVING MODIFICATION OF THE SITE PLAN APPROVED UNDER CITY OF DORAL RESOLUTION Z05-26, WHICH MODIFIED MIAMI-DADE COUNTY RESOLUTION 5-ZAB-135-97 AND 4-ZAB-157-89 TO PERMIT ADDITIONAL MAUSOLEUMS FOR THE PROPERTY LOCATED AT 11411 NW 25TH STREET, DORAL, FLORIDA; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Applicant, Our Lady of Mercy, has requested a modification of the site plan approved under City of Doral Resolution Z05-26 which modified Miami-Dade County Resolution 5-ZAB-135-97 and 4-ZAB-157-89 which was adopted by the Miami-Dade Board of County Commissioners to permit additional mausoleums at the property located at 11411 NW 25th Street, Doral, Florida; and

WHEREAS, on May 13, 2009 , the City Council held a public hearing and after careful view and deliberation, including a review of staff's recommendation, determined that it is in the best interests of the citizens of the City of Doral to approve the above referenced request;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA THAT:

Section 1. The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a part of this Resolution upon adoption hereof.

Section 2. The City Council of the City of Doral hereby approves the modification of the site plan approved under City of Doral Resolution Z05-26 which modified Miami-Dade County Resolution 5-ZAB-135-97 and 4-ZAB-157-89 which was adopted by the Miami-Dade Board of County Commissioners to permit additional mausoleums at the property located at 11411 NW 25th Street, Doral, Florida:

Section 3. This Resolution shall be recorded in the Public Records of Dade County, Florida, with the Applicant to pay the costs thereof.

Section 4. This resolution shall become effective upon its passage and adoption by the City Council.
