

RESOLUTION No. 15-200

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, ACCEPTING THE LOW BID AND AWARDING LIMITED INVITATION TO BID #2015-22 TO JAXI BUILDERS, INC.; AUTHORIZING THE CITY MANGER TO ENTER INTO AN AGREEMENT WITH JAXI BUILDERS, INC. FOR THE CONSTRUCTION OF THE POLICE-PUBLIC WORKS FACILITY ADDITION, IN AN AMOUNT NOT TO EXCEED \$7,100,816.80, INCLUSIVE OF A 10% CONTINGENCY, SUBJECT TO APPROVAL BY THE CITY ATTORNEY AS TO FORM AND LEGAL SUFFICIENCY, AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY IN FURTHERANCE THEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in response to Limited Invitation to Bid #2015-22 (“LITB”) for “Police-Public Works Facility Addition” (the “Project”), the City of Doral (the “City”) received three (3) bids by the September 4, 2015 deadline, with all three (3) companies meeting the required criteria; and

WHEREAS, upon review of bids received, Staff determined that JAXI Builders, Inc. was the lowest most responsive and responsible bidder (the “Contractor”); and

WHEREAS, a copy of Contractor’s Bid Submittal, LITB #2015-22 Inventory, Bid Tabulation, and Contract Agreement are attached as Exhibit A, which are incorporated herein and made a part hereof by this reference (“the Bid”); and

WHEREAS, staff has recommended that the City Council accept the bid by Contractor, award the LITB to Contractor, and authorize the City Manager to enter into an agreement with the Contractor in accordance with the terms of the Bid and such other terms as may be favorable to and in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted and incorporated herein and made a part hereof by this reference.

Section 2. Approval; Award; Authorization. Contractor's Bid is hereby accepted and the LITB is hereby awarded to Contractor. The City Manager is hereby authorized to negotiate and enter into an agreement with JAXI Builders, Inc. for the construction of the Project, in an amount not to exceed \$7,100,816.80 (which includes a 10% contingency amount for unforeseen conditions), a copy of which is attached hereto as Exhibit "B", together with such non-material changes as may be acceptable to the City Manager and approved as to form and legality by the City Attorney, is hereby approved. The City Manager is authorized to execute the Contract and expend budgeted funds on behalf of the City.


Section 3. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.


