

**RESOLUTION No.18-04**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY CODE OF ORDINANCES, APPROVING THE PURCHASE OF BIENNIAL RENEWALS, MAINTENANCE AND SUPPORT FOR PALO ALTO NETWORKS FROM CHAMPIONS SOLUTIONS GROUP, VIA STATE OF FLORIDA AGREEMENT PARTICIPATING ADDENDUM, GSA CONTRACT #GS-35F-0511T, IN AN AMOUNT NOT TO EXCEED \$57,185.61; AUTHORIZING THE CITY MANAGER TO EXECUTE THE AGREEMENT FOR BIENNIAL RENEWALS, MAINTENANCE AND SUPPORT WITH PALO ALTO NETWORKS, INC. AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City Council for the City of Doral (the "City") to purchase services from Palo Alto Networks, for license, renewals, service and support of the existing software that operates our security network infrastructure; and

**WHEREAS**, Palo Alto Networks is the existing appliance and software that operates our entire security perimeter throughout all City's facilities and the NAP location; and

**WHEREAS**, the Information Technology staff has reviewed the existing appliance and software licenses and support in order to inventory our license and support renewal and bring them up to date plus expand functionality; and

**WHEREAS**, maintaining a current secure environment with the latest versions and software patches is critical to the City's network security infrastructure and helps align our systems with industry best practices; and

**WHEREAS**, section 2-322 of the City Code of Ordinances permit the City to utilize the contracts entered into by other governmental entities, provided that the agreements are solicited and entered in a competitive manner similar to that in the City Code of Ordinance; and

**WHEREAS**, staff has reviewed the terms provided by Champion Solutions Group, via State of Florida agreement participating addendum, GSA CONTRACT #GS-35F-0511T, to be advantageous to the City; and

**WHEREAS**, staff has recommended the Mayor and City Council approve the purchase Palo Alto Networks Inc.'s software renewals, upgrades, service and support for the City's licenses using purchase of biennial upgrade, renewals, maintenance and support for Palo Alto Networks from Champion Solutions Group, via State of Florida agreement participating addendum, GSA CONTRACT #GS-35F-0511T in an amount not to exceed \$57,185.61 budgeted funds with funds payable from account #001.60005.500640.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval.** Pursuant to Section 2-322 of the City Code, the purchase of annual upgrade, renewals, maintenance and support for Palo Alto Networks Inc.'s Software from Champion Solutions Group, via State of Florida agreement participating addendum, GSA CONTRACT #GS-35F-0511T in an amount not to exceed \$57,185.61 is hereby approved.

**Section 3. Authorization.** The City Manager is hereby authorized to enter into an agreement and other contractual documents, subject to approval as to form and legal sufficiency by the City Attorney, as may be necessary to procure the Palo Alto Networks solution, and to expend funds in furtherance hereof.

**Section 4. Implementation.** The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

**Section 5. Effective Date.** This Resolution shall take effect immediately upon adoption.
