A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, SUPPORTING A FLORIDA TURNPIKE ENTERPRISE PROJECT THAT WILL WIDEN THE HOMESTEAD EXTENSION OF THE FLORIDA'S TURNPIKE AND PROVIDE A VEHICULAR RAMP OVER DORAL BOULEVARD AND **PROVIDE FOR A BICYCLE / PEDESTRIAN BRIDGE THAT WILL** CONNECT THE TURNPIKE TRAIL OVER DORAL BOULEVARD; APPROVING A WORK ORDER BETWEEN THE CITY OF DORAL AND A&P CONSULTING TRANSPORTATION ENGINEERS, A PREQUALIFIED VENDOR FOR THE DEVELOPMENT OF A **DESIGN CRITERIA PACKAGE FOR THE BICYCLE / PEDESTRIAN** BRIDGE OVER DORAL BOULEVARD, IN AN AMOUNT NOT TO EXCEED \$46,044.52; AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Florida Turnpike Enterprise ("FTE") has a design / build project programmed in 2017 that will widen the Homestead Extension of the Florida's Turnpike

("HEFT") from SR 836 to NW 57 Avenue; and

WHEREAS, City of Doral ("City") has had extensive communication with the FTE

for the inclusion of a vehicular ramp over Doral Boulevard that will connect traffic from NW

25 Street to the northbound on-ramp of the HEFT via NW 117 Avenue; and

WHEREAS, the FTE would also include a bicycle / pedestrian bridge that would connect the Turnpike Trial over Doral Boulevard if the City funds the construction and develops a design criteria package by the planned advertisement date of their project which is currently programmed for September 15, 2016; and

WHEREAS, A&P Consulting Transportation Engineers is a prequalified provider of professional engineering services selected in accordance with Consultant Competitive Negotiation Act requirements and approved by the City Council in December 2014; and

WHEREAS, Staff has recommended the Mayor and City Council support for the construction of a Bicycle / Pedestrian Bridge over Doral Boulevard and approve a Work Order with A&P Consulting Transportation Engineers, a copy of which is attached hereto as Exhibit "A", for development of the Design Criteria Package in an amount not to exceed \$46,044.52.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The City Council supports the construction of a Bicycle / Pedestrian Bridge that will connect the Turnpike Trial over Doral Boulevard. Work Order No. 6 for the development of a design criteria package in an amount not to exceed \$46,044.52, a copy of which is attached as Exhibit "A", together with such non-material changes as may be acceptable to the City Manager and approved as to form and legality by the City Attorney, is hereby approved. The City Manager is authorized to execute the Work Order and expend budgeted funds on behalf of the City.

<u>Section 3.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.

The City of Doral authorizes the firm of A&P Consulting Transportation Engineers to provide professional engineering services for the development of a Design Criteria Package for a Bicycle / Pedestrian Bridge over Doral Boulevard. The work should be performed in accordance with the contract provisions contained in the Continuing Professional Services Agreement between A&P Consulting Transportation Engineers and the City of Doral dated January 20, 2015, and the attached Proposal submitted by your firm for the above referenced project.

SCOPE OF SERVICES AND SCEHDULE:

The scope of the project will be as described in the attached proposal from A&P Consultant Transportation Engineers dated May 5, 2016 for the development of a Design Criteria Package for the proposed Bicycle Pedestrian Bridge over Doral Boulevard. The schedule requires the work to be performed within 50 calendar days. All limitations of time set forth in this Work Order are of the essence. The performance of services associated with this Work Order will be executed on a Time and Materials basis with a not to exceed amount of \$46,044.52.

You are required by the Continuing Service Agreement to begin work subsequent to the execution of this Work Order, or as directed otherwise. If you fail to begin work subsequent to the execution of this Work Order, the City of Doral will be entitled to disqualify the Proposal, and revoke the award.

Work Order incorporates the terms and conditions set forth in the Continuing Services Agreement dated January 20, 2015 between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply. Work Order is not binding until the City of Doral agrees and approves this Work Order.
