

RESOLUTION No. 14-91

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, ESTABLISHING THE PROPOSED MILLAGE RATE FOR FISCAL YEAR 2014-2015; THE CURRENT YEAR ROLLED-BACK RATE AND THE DATE, TIME AND PLACE OF THE FIRST AND SECOND PUBLIC BUDGET HEARINGS AS REQUIRED BY LAW; DIRECTING THE CITY CLERK AND CITY MANAGER TO FILE SAID RESOLUTION WITH THE PROPERTY APPRAISER OF MIAMI-DADE COUNTY PURSUANT TO THE REQUIREMENTS OF FLORIDA STATUTES AND THE RULES AND REGULATIONS OF THE DEPARTMENT OF REVENUE AND THE STATE OF FLORIDA; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on June 30, 2014, the Honorable Lazaro Solis, Property Appraiser of Miami-Dade County (the "Property Appraiser"), served upon the City of Doral (the "City") a "Certification of Taxable Value" certifying to the City its 2014 taxable value; and

WHEREAS, The City Council has reviewed the taxable value supplied by the Property Appraiser; and

WHEREAS, the provisions of Florida Statutes Section 200.065 require that within thirty five (35) days of service of the Certification of Taxable Value upon a municipality, said municipality shall furnish to the Property Appraiser the proposed millage rate, the current year roll-back rate, and the date, time and place at which a public hearing will be held to consider the tentative millage rate and tentative budget and final millage rate and final budget; and

WHEREAS, The City Council desires to announce the dates of the first and second hearings to the Property Appraiser.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AS FOLLOWS:

Section 1. The proposed millage for the first public hearing is hereby declared to be 1.9280 mills which is \$1.9280 per \$1,000.00 of assessed property within the City of Doral. The proposed millage is 10.66% greater than the rolled-back rate.

Section 2. The current year rolled-back rate computed pursuant to Section 200.065 *Fla. Stat.*, is 1.7423 mills which is \$1.7423 per \$1,000.00 of assessed property within the City.

Section 3. That the date, time and place of the first and second public hearings are hereby set by the City Council as follows:

Section 4. The City Clerk and City Manager are directed to attach the original Certification of Taxable Value to a certified copy of this Resolution and serve the same upon the Honorable Lazaro Solis, Miami-Dade County Property Appraiser, on or before August 04, 2014.

Section 5. This Resolution shall be effective immediately upon adoption.
