

**RESOLUTION NO. 11 – 19**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH PASCUAL, PEREZ, KILIDDJIAN & ASSOCIATES FOR THE PROVISION OF CONSTRUCTION MANAGEMENT SERVICES FOR THE FUTURE CITY GOVERNMENT FACILITY IN AN AMOUNT NOT TO EXCEED \$180,000.00; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, during the August 2010 Council Meeting, the City Council authorized the purchase and sale agreement with CM Doral CH Development LLC for the City Government future site; and

**WHEREAS**, following the purchase agreement the City Council approved the contract with CM Doral and the City of Doral for the construction of the future City Government Facility; and

**WHEREAS**, Pascual, Perez, Kiliddjian & Associates (PPK) have been involved in the architectural and design phase of the project and have provided Staff with technical support as well as architectural and construction management knowledge; and

**WHEREAS**, Staff respectfully requests that the City Council authorize the City manager to negotiate and enter into an agreement with PPK for the provision of construction management services for the future City Government Facility in an amount not to exceed \$180,000.00.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1.** The City Council hereby authorizes the City Manager to negotiate and enter into an agreement with PPK for the provision of construction management

services for the future City Government Facility in an amount not to exceed \$180,000.00.

**Section 2.** This Resolution shall become effective immediately upon its adoption.
