

**RESOLUTION No. 20-67**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE TRANSFER IN FISCAL YEAR 2019-2020 OF HURRICANE DORIAN EXPENDITURES FROM THE EMERGENCY FUND TO THE GENERAL FUND; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, On August 30, 2019, the City of Doral Parks & Recreation Department began its hurricane preparation in anticipation of the potential impact from Hurricane Dorian. As part of the hurricane preparation process, the Parks & Recreation Department removed all shade canopies from its facilities to ensure that they would not be damaged by the storm and that the infrastructure which holds the canopies were not damaged as well; and

**WHEREAS**, On November 19, 2019, Resolution No. 19-277 authorized the City Manager to negotiate and enter into an agreement with No Equal Design for the reinstallation of shade canopies at parks in an amount not to exceed \$58,520.00. Funding was approved from account 107.90005.500460, the Emergency Fund's Repair & Maintenance account.; and

**WHEREAS**, On December 3, 2019, the Miami-Dade office of Emergency Management notified the City that Miami-Dade County, and its municipalities, did not meet the Federal threshold to be included in the Federal declaration for Hurricane Dorian;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted and incorporated herein and made a part hereof by this reference.

**Section 2. Approval & Authorization.** The Mayor and City Council hereby approves the transfer of the expenditures for the reinstallation of shade canopies at the parks from account 107.90005.500460, Emergency Fund's Repair & Maintenance to account 001.50005.500492, General Government's Contingent Reserve account.

**Section 3. Implementation.** The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

**Section 4. Effective Date.** This resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Councilmember Mariaca who moved its adoption. The motion was seconded by Councilmember Cabral and upon being put to a vote, the vote was as follows:
