A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, REQUESTING OUR STATE AND HOUSE LEGISLATURES TO WORK TOGETHER WITH THE MIAMI-DADE COUNTY MAYOR IN FINDING A RESOLUTION THAT BENEFITS ALL OF THE CITIZENS OF MIAMI-DADE COUNTY; KEEPS LOCAL TOLL REVENUES AFFORDABLE FOR ALL RESIDENTS; AND ENSURES THAT MIAMI-DADE COUNTY WILL RECEIVE SUFFICIENT REVENUE TO FUND ROADWAY AND INFRASTRUCTURE IMPROVEMENTS REQUIRED TO ACCOMMODATE THE GROWTH IN THE COUNTY; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, House Bill ("HB") 385 by Representative Bryan Avila (R-Hialeah) and Senate Bill ("SB") 898 by Senator Manny Diaz (R-Hialeah) have been filed for consideration during the 2019 session of the Florida Legislature; and

WHEREAS, HB 385 and SB 898, if passed by the Florida Legislature in their current form, would abolish the Miami-Dade Expressway Authority ("MDX") and transfer all the MDX's assets and liabilities, including outstanding bond obligations, to the Florida Department of Transportation ("FDOT"); and

WHEREAS, Miami-Dade County through Mayor Carlos A. Gimenez has proposed, as an alternative to the abolishment of the MDX, the creation of a new transportation authority that would assume all assets and liabilities of the MDX and the facilities of the portion of the Homestead Extension of Florida Turnpike ("HEFT") within Miami-Dade County ("proposal"); and WHEREAS, the Mayor and Council wish to request that the House and Senate work together with our County Mayor to keep local toll revenues in Miami- Dade County affordable for all residents of Miami -Dade County and ensure that adequate funding will be committed to fund the much-needed infrastructure improvements.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF DORAL CITY COUNCIL:

<u>Section 1.</u> <u>Recommended Position</u>. The Mayor and City Council requests that both the House and State representatives and Miami-Dade County Mayor Carlos A. Gimenez work together to arrive at a solution that is in the best interests of the citizens of Miami-Dade County.

<u>Section 2</u>. <u>Recitals</u>. The foregoing recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

<u>Section 3.</u> <u>Transmittal.</u> The City Clerk is hereby directed to transmit this Resolution to the Mayor of Miami-Dade County to ensure that the City's position with this regard is clearly received and understood.

Section 4. Effective Date. This resolution shall become effective immediately upon its adoption.
