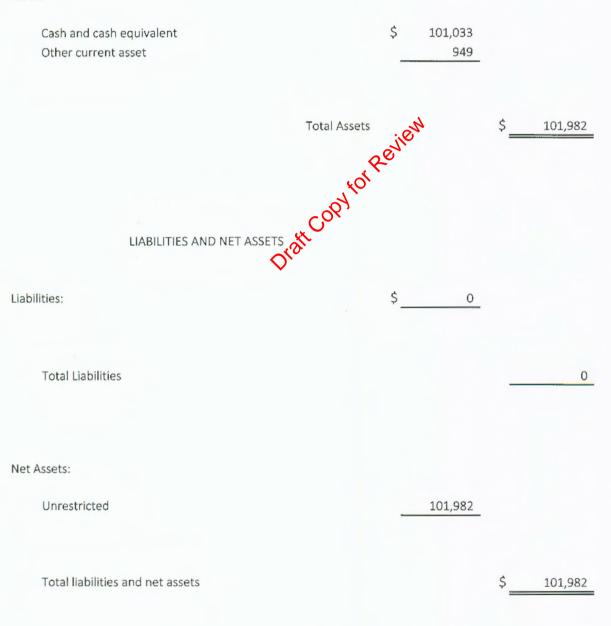

The purpose of this memorandum is to provide research findings on government foundations similar to the Parks and Police 4 Kids Inc. in order to revise its mission and method of governance.

Background of Parks and Police for Kids Foundation

Parks and Police 4 Kids, Inc. is not-for-profit organization that was created in 2006 by the City of Doral and charged with the task of meeting the needs of the community. This corporation was established to provide child welfare and family services via recreational, educational and social programs for the citizens of Doral. Programming initiatives would be implemented with the aide of the City of Doral Parks and Recreation and Police Departments.

Current Mission Statement

Parks & Police 4 Kids, Inc. (PP4K) is a City of Doral 501(c)(3) organization whose mission aims to facilitate and enable recreation, education and social programs for our young residents, with a primary focus of preventing juvenile delinquency. PP4K, through its programs and services, will create a positive and safe environment for Doral's youth making our community an even better place to Live, Work, Learn and Play.

Some of the programs and activities that Parks & Police 4 Kids, Inc. would facilitate as initially proposed in 2006-2007 were:

- Youth Sports Leagues
- First Tee Program
- Food Drives
- Toy Drives
- Say Boo to Drugs Poster Contest
- Homework Club

- Summer Camp
- Scholarship Program

<u>Research</u>

Research was conducted to explore how other government agencies are structuring and operating their not-for-profit organizations for comparison purposes. Several municipalities were looked at as a potential model or guide to achieve reorganization for Parks and Police 4 Kids.

The following organizations were further researched:

- Palmetto Bay Foundation
- Community Foundation of Pinecrest
- Parks Foundation of Miami-Dade
- Miami-Dade Public Library Foundation, Inc.
- Coral Gables Community Foundation
- Arcata Foundation
- City of Muskogee Foundation

The City of Winter Park, City of Naples, City of Wellington, City of Cocoa Beach, Village of Key Biscayne, City of Arcadia, Panama City, City of Sunrise, City of Weston, City of West Palm Beach and City of Seminole were also researched but it was found that they do not have government non-profit foundations/organizations.

Palmetto Bay Foundation, Inc.

The Palmetto bay Foundation is a 501(c)(3) organization intended to assist the Village of Palmetto Bay in its goal to enhance the lives of all village residents and serve the community at large. The foundation was formed to raise the educational and social levels of the residents of the Village of Palmetto Bay and to foster and promote community-wide interest and preservation of the Palmetto Bay history.

Its purpose is to support programs that are charitable, educational and scientific in nature, and which are intended to serve a public interest, particularly for the Palmetto Bay community. The foundation will accomplish this by seeking funding opportunities available to foundations and nonprofit organizations, gifts and contributions that further its charitable and educational goals.

Method of Governance:

The board of directors is composed of five (5) members, which are currently members of the Palmetto Bay Council. According to the foundation's by-laws, the board is vested with the management of the business and affairs of the foundation.

Community Foundation of Pinecrest, Inc.

The Community Foundation of Pinecrest, Inc. benefits community improvement, capacity building, and neighborhood development. Community Foundation of Pinecrest, Inc. was established in 2009 and its legal structure is a corporation. The organization is classified as a 170(b)(1)(a)(vi) organization, which indicates it receives a substantial part of its support from a governmental unit or the general public.

Contributions to this foundation are tax deductible. Community Foundation of Pinecrest, Inc. is a government instrumentality.

The foundation's main goals are to build a permanent endowment as well as other funds that will serve the community now and forever, to promote philanthropy and help donors achieve their charitable goals, to support and strengthen our local nonprofit organizations and to provide leadership, guidance and resources to identify and meet local needs.

The encouraged forms of donations are event sponsorship, unrestricted funds, scholarship funds, and donor advised funds.

Method of Governance:

The board of directors is made up of Village of Pinecrest residents. In the past this foundation was first directed by the village council, but is not a completely separate non-profit 501(c)(3) corporation.

Parks Foundation of Miami-Dade

The Parks Foundation of Miami-Dade is a not-for-profit organization whose mission to foster the recreational, educational, environmental, and cultural life of Miami-Dade County community by encouraging and soliciting support for our county's park system. The foundation's mission sets out to enhance the quality of life for Miami-Dade residents and visitors by securing dedicated funding to preserve and promote parks and parks programming throughout Miami-Dade County.

Priorities include support of the Open Space Master Plan and Recreation Plan implementation through advocacy and capital development; the expansion of the Parks and Recreation Department's youth and senior programming by offering scholarships to the disadvantaged and youth with disabilities; building the foundation's capacity to provide financial stability; and enhancing the foundation's visibility in Miami-Dade County while achieving organizational excellence.

The Parks Foundation of Miami-Dade has supported programs and projects such as Fit2Play Scholarship Fund, Morning Mile, Swim for Jenny Scholarship Fund, Bike305 initiative, Beach Clean Up, development of Brickell Promenade, Histrotic Preservation, Deering Point Improvements, Youth Sports Championship Series, West End Holiday Magic and Noches Tropicales upon many others.

The Parks Foundation of Miami-Dade has proudly reported the following community impact:

- Provided financial support for Health and Fitness, Cultural, Environmental and Educational programs serving over 8,000 children, 264 seniors and 2,500 persons with disabilities
- Provided over 1,500 children with swimming lessons, free of charge
- Nearly 600 children were provided safe, structured after-school programs at no or low-cost
- More than 700 children learned how to bike safely, in partnership with the University of Miami's BikeSafe[™] Program.
- Provided support to more than 50 girls between the ages of 11 to 15 registered each year in the G.EM. (Girls Empowerment and Mentoring) Program with projects, workshops and mentoring opportunities to build self-esteem, strengthen their connection to the community, and provide quality arts experiences.
- Attracted 35,000 visitors to arts and culture, recreation and community events

- Hosted 20 community events including movie nights, farmer's markets, concerts, festivals, and tournaments
- Hosted over 1,500 volunteers in community service activities including park beautification, clean-up and program enrichment

Method of Governance:

The board of directors consists of ten (10) members, one of whom is the Miami-Dade County Parks & Recreation Director. There is also a 27- member Citizens Advisory Committee that also makes recommendations to the board to improve and promote Miami-Dade Parks' facilities and programs.

Miami-Dade Public Library Foundation, Inc.

The Miami-Dade Public Library Foundation, Inc. is a not-for-profit organization that was founded to enhance the services and programs of the Miami-Dade Public Library System. The mission of the Foundation is to serve as the fundraising arm of the Library primarily for the endowment of major capital projects, major educational, and cultural community projects as specifically approved by the library system and the foundation.

Method of Governance:

The board of directors consists of 20 community members.

Coral Gables Community Foundation

Established in 1991, the Coral Gables Community Foundation is led by community leaders, with individuals looking to positively impact the success of the community. It is a nonprofit 501 (c) (3) organization, the mission of the Coral Gables Community Foundation is to foster programs and initiatives that enhance the quality of life for people living and working in "The City Beautiful" Coral Gables.

The Coral Gables Community Foundation supports scholarships such as Grant & Bridget Daugherty Nursing Scholarship, Kerdyk Family Trust Scholarship Fund and Lady Suzanna P. Tweed Scholarship Fund. The foundation also hold annual events to fundraise such as an annual gala, a food tour named Tour of Kitchens, The Ponce Society of Young Professionals and Mad Hatter cocktail at a local restaurant.

Method of Governance:

The board of directors consists of 25 members, one of whom is a City of Coral Gables Commissioner.

Arcata Foundation (California)

The purposes of the Arcata Foundation are to lessen the burdens of government and to promote and support the educational, human services, cultural, recreational, historical, peace-related, and environmental needs of the City of Arcata.

Projects supported by the foundation should do one or more of the following:

- Support the educational needs of local citizens (of all ages)
- Support those in need of human services, such as health care, child care, housing, etc.
- Support art and cultural activities and education within the community
- Provide recreational activities and programs to the community (all ages)
- Support and protect the environment of the community
- Support peace-related activities and education
- Support activities and education related to the history of the City of Arcata

Method of Governance:

The board of directors consists of no less than four and no more than eight voting members approved by the City Council serving terms of four years. The Finance Director is staff liaison to the Board of Directors.

Further information can be found on Exhibit F "Arcata Foundation Application."

City of Muskogee Foundation (Oklahoma)

With a mission to make real difference, the City of Muskogee Foundation was established in 2008 for the purpose of effectively developing, supporting, promoting, and improving programs and facilities relating to education, arts, culture, community revitalization and beautification, social services, health care, economic development infrastructure, housing and recreation for the City of Muskogee and surrounding areas and to improve the quality of life of resident of Muskogee.

The foundation funds four primary grants in the areas of economic development, education & empowerment, health & wellness, and quality of life.

Method of Governance:

The City, as sole member of the Corporation, shall be eligible and authorize to vote, to furnish any necessary consent or approval, or to take action on any issue that may properly be presented to the City as the member of the Corporation. The Board of Directors shall not be less than three or more than 15, determined by the City Council. Currently, the board consists of two council members, the Mayor and the City Manager. Each member of the council may nominate three candidates for the board, as well.

Further information can be found on Exhibit G "City of Muskogee Foundation."

General Observations

Based on research the following observations have been made:

- Government foundations are generally set up as separate not-for-profit entities that operate under the guidance of a board of directors.
- The board of directors is appointed by the government agency. Appointed members are leaders in the business community. A government official(s) may serve on the board or serve as a liaison to the board.
- Foundations also often utilize a small staff for the day to day operations and for consistency.
- The primary purpose of the foundations is to serve as an entity through which funds can be solicited to service the needs of populations within the community that they serve. Foundations are also used as tools of advocacy.
- Bylaws are authored to govern the operations of the foundation.
- It appears that foundations set up their own procurement policies. Often times that policy calls for a resolution by the board of directors. The government agency's procurement process appears to only come into play once the foundation provides the funding to the government.

Staff Recommendation

Proposed Mission Statement:

Parks & Police 4 Kids, Inc. (PP4K) is a City of Doral 501(c)(3) foundation whose mission aims to empower youth in reaching their full potential by building healthy relationships and preparing youth with the necessary tools to confront and overcome challenges through recreation, education and social programs, with the primary focus of preventing juvenile misconduct.

PP4K will create a positive and safe environment for Doral's youth making our community an even better place to Live, Work, Learn and Play.

Proposed Method of Governance:

The Board of Director will consist of 7 members. Each of the Doral City Council members will appoint one community member to serve on the board. The Parks and Recreation Director or designee will serve and a business/non-profit owner from the community will be appointed by the City Manager's office, making it a board of 7 voting members.

Proposed Amendments to Current By-laws:

The Parks and Police 4 Kids, Inc. by-laws have not been updated since 2009. With the proposed mission statement and form of governance, below are recommendations for amendments:

Article III Board of Directors

- Section I General Powers:
 - Remove "The Board shall elect its own officers and adopt rules of procedures."
- Section 2 Number, Tenure and Qualifications and Duties:
 - Revise entire section to reflect the following: "The Board shall consist of seven (7) persons. Each Director shall serve the number of terms consistent with the term of the City Council member who appointed them. Each of the Doral City Council members will appoint one (1) community member to serve on the board. The Parks and Recreation Director or designee will serve and one (1) business/non-profit owner from the community will be appointed by the City Manager's office."
- Section 3 Resignation and Removal:

- Keep the following: "A Director may resign at any time by providing notice to the Secretary in writing."
- Replacing the remaining current information to reflect the following: "The Secretary will then provide the letter of resignation to the City Clerk's Office which will then contact the City Council member who appointed them, in order to replace the member."
- Add the following: "A Director can only be removed if it is determined that the Director is not contributing positively to the mission. It can be executed by the President or Vice President brings the request in front of the City Council and is approved by a majority vote. Any Director, who misses three (3) consecutive meetings, without being excused by the Board President, shall be deemed to have resigned."
- Section 4 Regular Meetings:
 - Revise entire section to reflect the following: "Meeting of the Board shall be held monthly, with the exception of December and July. The annual meeting, for purposes of officer elections, will take place each January."
- Section 5 Special Meetings:
 - Revise entire section to reflect the following: "Special meetings of the Board may be called by the City Clerk's office at the request of any of the Directors, with 5/7 or more Board members agree to attend."
- Section 7 Quorum:
 - Revise section to include new number of quorum: "5/7 of the Directors must be present in person in order to constitute a quorum..."

Proposed Fundraising Efforts:

The Parks and Police 4 Kids, Inc. should focus on fundraising efforts for their initiatives in the following ways:

- City of Doral Police Department Off-Duty additional \$1.25 per hour
 An estimated \$15,000 per year
- Revenue from annual Mayor & Council Gala (This fundraiser can take place on foundation is more established)
- Corporate Sponsorships
- Private Donations by community members and organizations
- Public Grants

Proposed Programs and Activities funded by foundation:

The programs and activities funded by the Parks and Police 4 Kids, Inc. should be in line with its mission. The primary focus should be funding programs and activities that directly benefit the prevention of juvenile misconduct in the City of Doral community. The following are some examples of programs that can be funded:

- Scholarships for sports and cultural programs based an approved set of criteria and application. The scholarship recipients will be selected by a designated committee.
- Interview Skills Seminars at local high schools for students
- Afterschool police programs for at risk students
- Community events for youth such as Back to School Night

Exhibit A

Palmetto Bay Foundation, Inc.

The Palmetto Bay Foundation is a 501(c)(3), nonprofit organization intended to assist the Village in its goal to enhance the lives of all Palmetto Bay residents and serve the community at large.

The Foundation was formed to raise the educational and social levels of the residents of the Village of Palmetto Bay and to foster and promote community-wide interest and preservation of the Palmetto Bay history. Its purpose is to support programs that are charitable, educational and scientific in nature, and which are intended to serve a public interest, particularly for the Palmetto Bay community. The Foundation will accomplish this by seeking funding opportunities available to foundations and nonprofit organizations, gifts and contributions that further its charitable and educational goals. To that extent, the Village will be hiring a grantwriter specializing in the foundation arena to secure funding in accordance with the priorities of the Foundation as well as the Village.

The Foundation is guided by a Board of Directors composed of five members. The Board is vested with the management of the business and affairs of the Foundation. The Board of Directors consists of the following members:

BYLAWS OF PALMETTO BAY FOUNDATION, INC.

INTRODUCTION

These bylaws constitute the code of rules adopted by Palmetto Bay Foundation, Inc. for the regulation and management of its affairs.

MEMBERSHIP

There shall be one "member" of this Corporation. The one member is the Village of Palmetto Bay Village Council.

DIRECTORS

Definition of Board of Directors: The Board of Directors is that group of persons vested with the management of the business and affairs of this Corporation subject to the law, the Articles of Incorporation, and these bylaws.

Qualifications: Directorships shall not be denied to any person on the basis of race, creed, sex, religion, or national origin.

Number of Directors: The board of directors will consist of five directors.

Selection and Terms of Directors: All directors shall be appointed by the Member. The Member may remove a director at any time for any reasons. The Member shall inform the Secretary in writing of all such appointments and removals. The appointment or removal shall be effective only upon receipt of this written communication. This Corporation shall not be bound by such appointments and removals unless the person signing the written communication has first received express authority from the Member corporation pursuant to the provisions of Florida corporate law. All directors shall serve until they either resign or are removed pursuant to these bylaws.

Removal from Office: Any Board Member may be removed from office by a vote of the Board of Directors when he or she misses three consecutive regular meetings.

Vacancies: Resignations of directors shall become effective immediately or on the date specified therein and vacancies will be deemed to exist as of such effective date. Any vacancies on the Board of Directors resulting from the removal or the resignation of a board director shall be filled by the Member. The Secretary shall notify the Member of all vacancies in writing reasonably soon after the vacancy occurs.

Place of Director's Meetings: Meetings of the board of directors, regular or special, will be held at the primary place of business for this Corporation or at any other place within or without the State of Florida as provided or such place or places as the board of directors may designate by resolution duly adopted.

Meetings: Meetings of the Board may be called by:

- 1. the Board of Directors
- 2. the President
- 3. the Secretary upon the written request of one third of directors.

Verbal notice shall be given to each board member no later than twentyfour hours prior to the meeting with the exception of meetings held to amend the articles of incorporation or the by-laws, for which written notice of five days shall be required.

Waiver of Notice: Attendance by a Director at any meeting of the Board of Directors will constitute a waiver of notice of such meeting except where such Director attends the meeting for the express purpose of objecting, at the beginning of the meeting, to the transaction of business because the meeting is not lawfully called or convened.

Quorum: A majority of the incumbent directors (not counting vacancies) shall constitute a Quorum for the conduct of business. At Board meetings where a quorum is present, a majority vote of the Directors attending shall constitute an act of the Board unless a greater number is required by the Articles of Incorporation or any provision of these bylaws.

Self Dealing: No director shall use confidential information gained by reason of being a member of the board of directors for personal gain to the detriment of the corporation. Any director who so abuses confidential information shall be removed from the board by a vote of the board of directors at a meeting wherein prior notice of the nature of the proposed removal has been given to each director.

OFFICERS

Roster of Officers: The Corporation shall have a President, Vice President, Secretary, and Treasurer. A person may hold more that one office.

Selection and Removal of Officers: All officers shall serve one year terms. Officers shall be elected by the Board of Directors at the January meeting or as soon as practical thereafter. Officers shall remain in office until their successor has been selected.

President: The President shall be the chief executive officer of this Corporation and will, subject to the control of the Board of Directors or the Executive Committee, supervise and control the affairs of the Corporation. The President will perform all duties incident to sucb office and such other duties as may be provided in these bylaws or as may be prescribed from time to time by the Board of Directors. The President shall preside at all board meetings and shall exercise parliamentary control in accordance with Roberts Rules of Order.

Vice President: The vice President shall act in place of the president in the event of the chairperson's absence, inability, or refusal to act, and shall exercise and discharge such other duties as may be required by the board.

Secretary: The Secretary will keep minutes of all meetings, will be the custodian of the corporate records, will give all notices as are required by law or these bylaws, and generally, will perform all duties incident to the office of Secretary and such other duties as may be required by law, by the Articles of Incorporation, or by these bylaws.

Treasurer: The Treasurer will have charge and custody of all funds of this Corporation, will oversee and supervise the financial business of the corporation, will render reports and accountings to the Directors as required by the Board of Directors, and will perform in general all duties incident to the office of Treasurer and such other duties as may be required by law, by the Articles of Incorporation, or by these bylaws or which may be assigned from time to time by the Board of Directors.

Removal of Officers: Any officer cletted or appointed to office may be removed by the Board of Directors whenever in their judgment the best interests of this Corporation will be served. Such removal, however, will be without prejudice to any contract rights of the Officer so removed.

INFORMAL ACTION

Waiver of Notice: Whenever any notice whatever is required to be given under the provisions of the law, the Articles of Incorporation, or these bylaws, a waiver of such notice in writing signed by the person or persons entitled to notice, whether before or after the time stated in such waiver, will be deemed equivalent to the giving of such notice. Such waiver must, in the case of a special meeting of members, specify the general nature of the business to be trans acted.

Action by Consent: Any action required by law or under the Articles of Incorporation or by these bylaws, or any action which otherwise may be taken at a meeting of either the members or board of directors may be taken without a meeting if a consent in writing, setting forth the action so taken, is signed by all of the persons entitled to vote with respect to the subject matter of such consent, or all directors in office, and filed with the secretary of the Corporation.

COMMITTEES

Appointment of Committees: The Board of Directors may from time to time designate and appoint one or more standing committees as it sees fit. Such committees shall have and exercise such prescribed authority as is designated by the Board of Directors.

Executive Committee: The eight officers of the Corporation shall constitute the executive committee. The President shall act as chairperson of the executive committee. The Executive Committee shall have such authority as may be given to it from time to time by Resolution of the Board of Directors.

OPERATIONS

Execution of Documents: Except as otherwise provided by law, checks, drafts, and orders for the payment of money of this Corporation shall be signed by at least two persons who have previously been designated by a Resolution of the board of directors. Contracts, promissory notes, leases, or other instruments executed in the name of and on behalf of the Corporation shall be signed the agent designated by the board of directors. No contract shall be valid unless it is authorized or ratified by a properly adopted Resolution of the board of directors.

Books and Records: This Corporation will keep correct and complete books and records of account, and will also keep minutes of the proceedings of Board Member meetings, Executive Committee, sub-Committees. The Corporation will keep at its principal place of business a membership register giving the names, addresses, and showing classes and other details of the membership of each, and the original copy or a copy of its By-Laws including amendments to date certified by the Secretary of the Corporation.

Inspection of Books and Records: All books and records of this Corporation may be inspected by any Board member, of his agent or attorney, for any proper purpose at any reasonable time on written demand under oath stating such purpose.

Inspection of Books and Records: All books and records of this Corporation may be inspected by any Director for any purpose at any reasonable time on written demand.

AMENDMENTS

The Board of Directors may adopt Articles of Amendment (amending the Articles of Incorporation). Articles of Amendment must be adopted in accordance with Florida Law. The bylaws may be amended at anytime by a vote of the majority of directors at a meeting where a quorum is present. All amendments to the bylaws and the articles or incorporation are not valid unless consented to in writing by the Member.

INDEMNIFICATION

Any person (and the heirs, executors and administrators of such person) made or threatened to be made a party to any action, suit of proceeding by reason of the fact that he is or was a Director or Officer of the Corporation shall be indemnified by the Corporation against any and all liability and the reasonable expenses, including attorney's fees and disbursements, incurred by him (or by his heirs, executors or administrators) in connection with the defense or settlement of such action, suit or proceeding, or in connection with any appearance therein, except in relation to matters as to which it shall be adjudged in such action, suit or proceeding that such Director or Officer is liable for negligence or misconduct in the performance of his duties. Such right of indemnification shall not be deemed exclusive of any other rights to which such Director or Office (or such heirs, executors of administrators) may be entitled apart from this Article.

Fit2Play

More than just a way to spend leisure time, recreation programs provided by Miami-Dade Parks, and supported by the Parks Foundation, are designed to ensure that all residents have access to quality, affordable activities that promote inclusiveness. Miami-Dade Parks' Fit2Play Out-of-School Program is being touted a national model for the promotion of good health. An ongoing study conducted by the University of Miami Miller School of Medicine shows Fit2Play is preventing obesity and decreasing hypertension in children ages 6-14. Study results are being published in the American Journal of Health Promotion.

Fit2Play Scholarship Fund

More than 580 children received scholarships to attend Fit2Play programs at low- or no-cost in 2013 thanks to donations to the Fit2Play Scholarship Fund. The fund was created to preserve recreation programming for low-income families. Dollars donated to the scholarship fund receive 100% matching funds.





UnitedHealthcare, through CBS EcoMedia's WellnessAd program, funded 38 Fit2Play Scholarships at Olinda Park. The \$74,000 investment also provided a shade structure over the fitness court, and a planting and beautification project at both Olinda and Jefferson Reaves Parks.

Morning Mile

Together with AvMed, the Morning Mile Program expanded to all 42 Miami-Dade Parks' Fit2Play Summer Camps in 2013. Children begin their day with a run-jogwalk and receive incentives along the way. Developed by Fitzness International, the program teaches children to incorporate physical fitness into their daily routines.







Five-time NBA All-Star Tim Hardaway, Olympic Coach and University of Miami Director of Track & Field and Cross Country Amy Deem, and Olympic hurdler Bershawn Jackson kick-off an expanded Morning Mile program, sponsored by AvMed.



Sebastian Deoleo, a 14-year-old who attends Miami-Dade Parks' Fit2Play Summer Camp at Hammocks Community Park, ran a total of 140-miles as part of the Morning Mile Program, sponsored by AvMed. Another 55 children also reached the 100-mile or more mark.

For every child who runs 100 miles over the course of the summer as part of the Morning Mile program, \$100 can be donated to the Parks Foundation's Fit2Play Scholarship Fund.



Tennis

Lifetime sports including tennis and golf are part of Miami-Dade Fit2Play programming.



A \$3,800 grant from the United States Tennis Association helped provide equipment to support tennis programming in Miami-Dade Parks. USTA's 10 and Under Tennis program is utilized in Fit2Play camps.

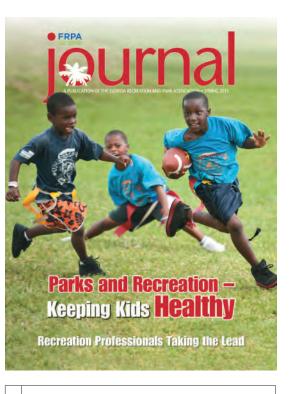

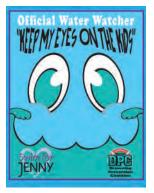

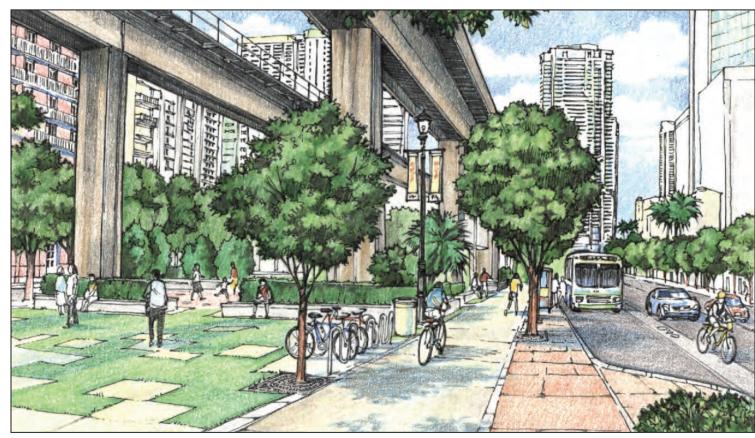

Projects

Partnerships with like-minded foundations, individuals, corporations and other governments have allowed the Parks Foundation and Miami-Dade Parks to improve existing facilities and develop new projects to enhance the public realm.

Brickell Promenade



The development of Brickell Promenade is part of a larger vision to enhance the M-Path, a 10-mile paved multi-use trail beneath the elevated Metrorail guideway. A \$1 million Transportation Alternative Program grant will help fund the project.

Miami Mobile



Currently in testing, the Miami Mobile application, developed by IBM, is designed to support the maintenance of Brickell Promenade, a proposed transit-oriented public space along Metrorail's Brickell Station. Miami Mobile will promote Brickell-area businesses and events by providing information and incentives to consumers, while also providing transit experts meaningful data on ridership patterns.



Technology Learning Centers

The Lili beetles are a chemical-free means of controlling air potato plants which stifle and destroy native landscaping.

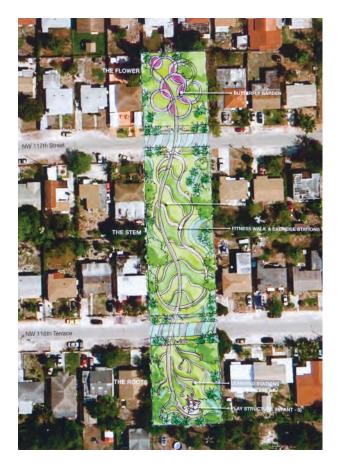

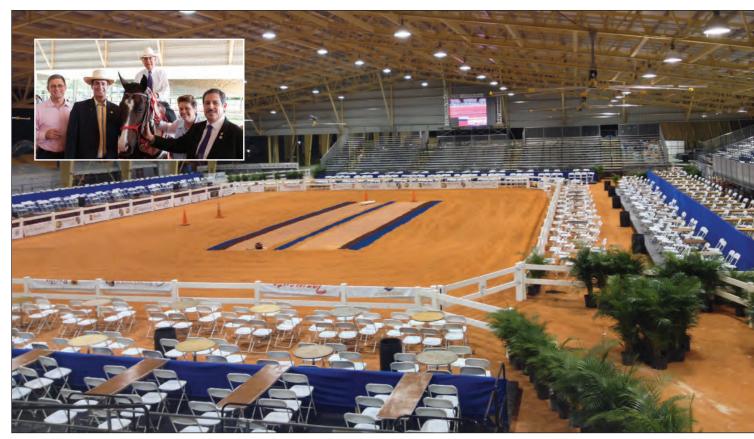

Open Space Master Plan

Miami-Dade County completed 93 construction projects in 2013 valued at \$47 million.

FACT:

Connecting great parks and public spaces through greenways and trails is a major component of the Open Space Master Plan, which guides the development of the public realm. Two new trails came online in 2013, adding another 11+ miles to Miami-Dade County's trail system.



Snake Creek Trail (North) - The newly opened 3.4 mile Trail along Miami Gardens Drive features a 10-foot wide asphalt surface connecting parts of North Miami Beach, Miami Gardens and unincorporated Miami-Dade. Amenities include two landscaped mini-parks with rubberized play climbers for tiny tots, rain shelters, benches and bicycle racks.



Black Creek Trail (South-West) - Extending from Larry and Penny Thompson Park to Black Point Park and Marina, the 8.4 mile Black Creek Trail is now widened, resurfaced and enhanced with additional trail segments. Amenities include landscaping, wayfinding signage, rest areas and small shelters.

River of Grass Greenway - At the request of the National Park Service and with the help of a \$1.5 million grant, Miami-Dade Parks is managing the planning of the River of Grass Greenway, a 12-14 foot wide corridor through the Everglades which will extend from Miami-Dade's Krome Avenue to Naples.

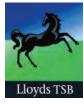

(CIAB), chaired by Miami-Dade County Commissioner Dennis Moss, the CIAB is a multijurisdictional collaborative dedicated to creating beautiful gateways, corridors and connections through maintenance and aesthetic improvements.

Wildlife Conservation



Part of the Biscayne Bay Coastal Wetlands Project and the Comprehensive Everglades Restoration Plan (CERP), the Deering Estate Flow-way and Cutler Slough Rehydration Projects are part of a larger effort to help restore the quantity, quality, timing and distribution of fresh water in the South Florida ecosystem. Expedited by the State of Florida and the South Florida Water Management District, the restoration of seasonal water flows, which was completed in Spring 2013, is anticipated to improve habitat for ferns, bromeliads, and orchids, including rare, endangered, or threatened species found within the surrounding natural areas.



Environmental Science and multi-disciplinary learning programs like the EcoAcademy, NESTT-Nurturing Environmental Stewards of today and tomorrow, Wildlife Conservation Program and various Field Study Trips offered by the Deering Estate at Cutler, ZooMiami and various nature centers connects students, teachers, youth groups and their families to the many natural and cultural resources in our community while improving academics and helping them to think critically about the world around them.

FACT:

Studies indicate that K-12 learning increases from 5% retention to 75% when students engage in hands on, experiential learning.

Historic Preservation



Stabilization, rehabilitation and restoration projects are ongoing at the Deering Estate at Cutler. A gift in honor of the late Charles Deering McCormick, Charles Deering's grandson, is providing interior and exterior surface maintenance to the historic buildings, while structural stabilization and restoration of the façade of the Richmond Cottage was provided by the Building Better Communities Bond Program.



Paleo-Indians, Tequestas, Seminoles, Afro-Bahamians, and Anglo-Americans have at different times, lived on the Estate grounds, each new group literally following in the footsteps of the preceding group. In 2013, the Estate received a \$75,000 grant from the Florida Department of State to conduct an archaeological survey and assessment of the Estate grounds.

DID ?

The Deerng Estate at Cutler was featured on the HGTV premiere of America's Spookiest Homes. The Estate offers monthly ghost tours led by interpretive staff and the League of Paranormal Investigators, our collaborative partner.

Zoo Biology



Joint research initiatives and internship opportunities are just the first steps in a research partnership forged by Zoo Miami and Florida International University. Following a ceremonial signing in 2013, efforts began to create a major wildlife conservation campus. The partnership is dubbed "Zoo Biology."

Maintaining the Public Realm

Miami-Dade Parks, Recreation and Open Spaces embraced its role as the keeper of countywide green spaces that enhance the beauty and environmental quality of neighborhoods. Through the Right of Way Asset and Aesthetics Management (RAAM) Division, landscape maintenance (mowing, litter collection, edging, weed removal, tree trimming, etc.) was performed on:

Future

With a vision of connecting people and parks for life, the Parks Foundation and Miami-Dade Parks forged ahead with new projects and initiatives designed to create a greener, more livable and economically vibrant Miami-Dade.



One of the world's most glamorous sporting events, the Sony Open is staying in Miami-Dade for the next 50 years. A renegotiated agreement with the International Players Championship will provide up to \$50 million in improvements at Crandon Park Tennis Center, at no cost to taxpayers. Amenities will include new stadia, dining options and player amenities.

With that 50-year commitment also comes a promise to provide opportunities that promote health and fitness through the game of tennis. Miami-Dade children will receive 500 tickets to the Sony Open each year, and the Parks Foundation will utilize a suite to strengthen the bonds between professional athletes, the corporate community and parks programs and services.

DID ?

The 14-day Sony Open creates an estimated \$300 million dollars in economic impact for Miami-Dade County.

Future

Arcola Lakes Senior Center





Miami-Dade County's first recreational facility specifically designed for use by active adults 55+ is scheduled to open in 2014. The 14,000+ square foot Arcola Lakes Senior Center will include entertainment rooms, an arts and crafts room, a ceramics room, exercise room, banquet meeting hall, therapeutic pool and more.

Miracle League



Children with special needs are playing baseball through the Miracle League of Miami-Dade. The Parks Foundation granted \$50,000 to the non-profit to help build a permanent special needs field at Tamiami Park, with support from the Miami Marlins Community Foundation. The new ballpark is currently in design.



Seasons 52



Seasons 52 is coming to Bill Bird Marina at Haulover Park. The restaurant, which offers seasonally-inspired dining choices and an award-winning international wine list, is part of a series of upgrades slated for the 245-acre property. A groundbreaking is expected in 2014.



Nearly 40 local municipalities, universities, state and national park agencies are members of the South Florida Parks Coalition. Coalition members meet to share knowledge and expertise with the goal of creating a model park system.

FACT: Nearly 30-percent of park operations are supported by earned revenues, not tax dollars.

Zoo Miami: Mission Everglades



Ground is breaking on Mission Everglades at Zoo Miami, a new \$40 million exhibit that will showcase the many ecosystems and animals within the River of Grass. Zoo Miami is also negotiating a \$980 million proposal with 20th Century Fox to add a theme and water park outside the zoo which could rival Orlando's greatest attractions.



Miami Watersports Complex

Extreme sports are coming to Amelia Earhart Park. The new Miami Watersports Complex will feature cable-driven wakeboarding and wakesurfing, as well as more traditional boat-powered wakeboarding and skiing. Patterned after a similar complex in Orlando, construction is set to begin in 2014.

Deering Theater



Theater is coming to the Deering Estate in 2014, part of an expansion of the Artist in Residence Program. Upgrades to the existing Visitor Center Auditorium are underway allowing it to serve as a black box community theater.

Recognition of Achievements

As the third largest parks system in the nation, Miami-Dade and the Parks Foundation continued to be recognized as an industry leader.



The Miami New Times voted Matheson Hammock Park the best park in Miami. Crandon Park and Greynolds Park also made the "Top 10" list.

Accredited since 1995 by the Commission for Accreditation of Park and Recreation Agencies (CAPRA), Miami-Dade Parks is continually recognized for its high standards and contributions to health and wellness in the Miami-Dade community.



The Parks Foundation participated in Give Miami Day, a 24-hour online giving event, sponsored by the Miami Foundation which raised a record \$3.2 million.





DID ?

Miami-Dade Parks is a three-time winner of the National Gold Medal Award from the National Recreation and Park Association.



Miami-Dade Parks received the 2013 Governor's Sustained Excellence Award, reaffirming its commitment to systematic performance improvement. It remains the first and only park and recreation agency in the State of Florida to be recognized by the Florida Sterling Council.

Six innovative programs in Miami-Dade Parks were recognized in 2013 by the National Association of Counties, including:

Miami-Dade Parks successfully administers more than \$20 million in state and federal grants that provide funding for land acquisition, capital development and more.

Recognition of Achievements



Miami-Dade Parks' Girls Empowerment and Mentoring Program (GEM), which inspires girls ages 11 to 16 with workshops and mentoring opportunities, received recognition in 2013 from the National Association of Counties (NACO). GEM builds self-esteem, provides quality arts experiences and strengthens the girls' connection to community. A visionary plan for Haulover Park captured the attention of a pre-eminent landscape architecture organization. The Florida Chapter of the American Society of Landscape Architects bestowed its 2013 Award of Honor to Miami-Dade Parks Planning & Development Division.





The City of Miami Beach gave Miami-Dade Parks' Beach Maintenance Operations high marks for cleanliness. Last year, more than 1,234 tons of debris were removed from a 15-mile stretch which includes Miami Beach, Surfside, Bal Harbour and Sunny Isles Beach. The 2013 Active Leisure for Life Award was given to Miami-Dade Parks' Disability Services Division by the Florida Disabled Outdoor Association for providing people with disabilities opportunities to participate in inclusive accessible recreation.



Showcasing a shared commitment to Miami-Dade County Youth, the Parks Foundation sold tickets to The Fair raising more than \$23,427 over the past two years for both non-profits.

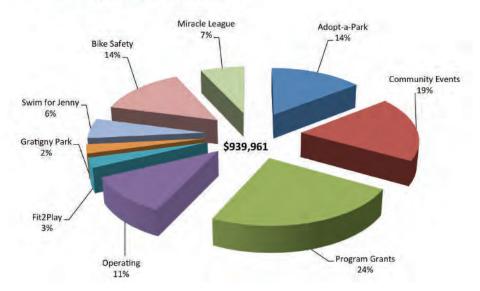

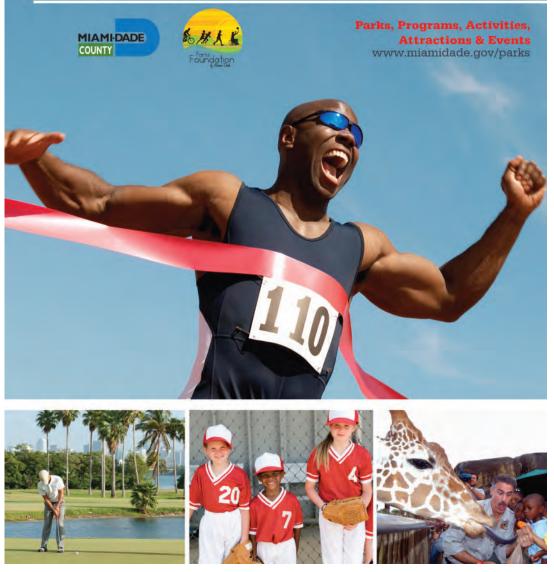

Letter from the President

t's our job to improve the parks and open spaces you love and together with like-minded foundations, corporate donors and individuals, we're touching more lives than ever before. The Parks Foundation of Miami-Dade had a banner year, raising more than \$800,000 to enhance parks and parks programming throughout the community. We helped provide 500 children free swimming lessons, transformed Tamiami Park's aging recreation center into a new place to play for children with disabilities, and implemented a run-jog-walk program with AvMed Health Plans which helped dozens of children lose weight and stay in shape, including a brother and sister who lost a combined 70 pounds!

We're not resting on our laurels. We are committed to raising another \$800,000 in 2013, including \$100,000 for Miami-Dade Park's nationally-recognized Fit2Play Programs. Dollars are providing recreational scholarships – and a safety net – for children who would otherwise have few safe, structured after-school and summer camp options. Investments like these in our children will pay dividends down the road. Plans are also on the table to showcase our community's 50-year vision for parks and open spaces through the creation of the first-ever transit-oriented park in Miami-Dade. Just as New York's High Line transformed a former elevated railroad spur into a linear park, Brickell Station Park will make use of scarce green space beneath Miami-Dade's Metrorail as we seek to create a seamless system of beautiful connections that move residents and visitors from place to place.

With a parks system so diverse and a Parks Department committed to excellence, innovation and stewardship, our Board's ability to provide stable and expanding mission-critical support is made that much easier. We invite you to see what we have accomplished together, where we are headed, and grow with us.

Letter from the Director

or more than 40 years, the National Recreation and Park Association has been the voice of America's Parks. In 2012, they dubbed Miami-Dade County Mayor Carlos Gimenez "Master of the Plan," saying our 50-year vision for parks and open spaces is setting the bar for parks systems all across the country. It was the latest feather in our cap as we seek to provide the outstanding recreational, natural and cultural experiences our residents and visitors have come to expect.

Park enhancements, large and small, came online in 2012. Homestead Bayfront Park welcomed a new restaurant and renovated atoll pool. Parks including West Perrine and Gwen Cherry unveiled new fitness zones. In 2013, we will break ground on a new Florida Exhibit at Zoo Miami and begin expanding Tropical Park's Equestrian Center. With an eye toward the future, we also combined our coastal parks and six marinas into one enterprise, setting the stage for enhanced revenue opportunities and an improved experience for park users.

Despite a slow economic recovery, we broke records. Zoo Miami and the Sony Ericsson Open enjoyed record attendance in 2012, and voters overwhelmingly approved the use of tournament revenues and private funds to enhance Crandon Tennis Center. We continue to embrace the power of partnerships. Corporate and non-profit partners, as well as volunteers, are enhancing our programs and keeping our parks beautiful. A gift of \$2.5 million for the restoration and preservation of the Deering Estate at Cutler is just one example.

With a commitment to providing excellent customer service, we implemented a comprehensive reorganization, reducing our workforce, while also assuming responsibility for 255-miles of median maintenance and the county's entire tree canopy. Our programs didn't skip a beat. In fact, the University of Miami's UHealth System determined our Fit2Play After-School Programs are improving the health of the hundreds of children we serve.

Still, we need to do more. While parks are an essential part of so many lives, more than half of children in unincorporated Miami-Dade live more than a mile from a county after-school program. Every child – and adult – deserves access to the safe places, wide open spaces and sense of community that our parks and parks programs provide. The benefits of parks to our health, economy and quality of life cannot be underestimated.

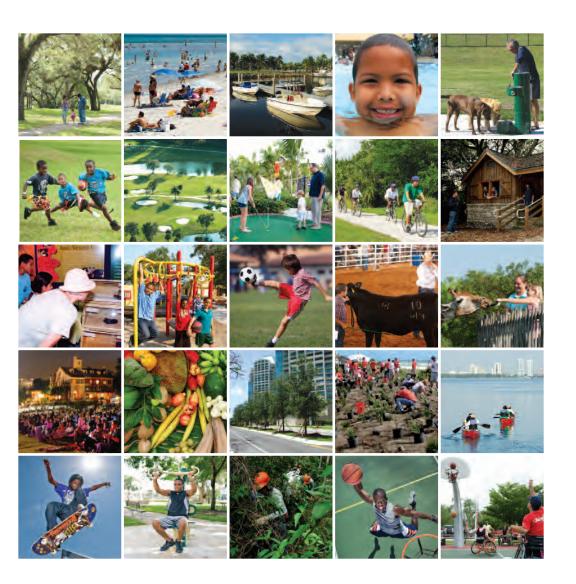

Our Programs

More than just a way to spend leisure time, recreation programs provided by Miami-Dade Parks, and supported by the Parks Foundation, are designed to ensure that all residents have access to quality, affordable activities that promote inclusiveness. More than **8,000 children, 500 seniors** and **2,500 persons with disabilities** are served each year.

FACT:

Of the 224,000 children who live in unincorporated Miami-Dade County, 56% (126,000) do **NOT** live within a mile of a Miami-Dade County recreation program.

FACTS:

- Kids spend an average of 6.5 hours a day with electronic media

 45 hours a week.
- 62% of children do not participate in organized sports
- 23% of children do not participate in any free-time activities

Fit2Play After-School Program

First-year results of a three-year-long study released in 2012 show Miami-Dade's Fit2Play After-School Program is making kids healthier. The University of Miami UHealth System used pre- and post- data from physical fitness and blood pressure tests, plus body mass index screenings, to determine Fit2Play prevents obesity and decreases hypertension in children ages 6-14. The program, which offers recreational games, nutritional education, an introduction to life sports, like golf and tennis, and homework help, is now being touted as a national model.

Fit2Play Summer Camps

The Morning Mile expanded to **28 Fit2Play Summer Camps** with support from AvMed Health Plans. Children start their morning with a run-jog-walk and receive incentives for every five miles logged. Developed by Fitzness International, the program teaches kids to incorporate physical fitness into their daily routines.

Campers participating in the **Morning Mile** collectively ran more than **53,200 miles**. AvMed Health Plans is expanding the program to all Miami-Dade Parks' Fit2Play Summer Camps in 2013.





eFit2Play

Currently in development, eFit2Play is a fun, educational, interactive website and wellness tool designed to further enhance the Fit2Play curriculum. Designed to track and incentivize physical education and healthy eating, children receive points that can be redeemed for free products and services.

Did you know?

The Parks Foundation provides **\$100,000 in scholarship funding** to disadvantaged children to attend after-school or summer camp programs at low or no cost, providing a vital safety net for children who might otherwise fall through the cracks.

Fit2Play Scholarship Fund

Created for families who simply cannot afford program fees, the Fit2Play Scholarship Fund offers disadvantaged children safe, structured activities free of crime, drugs and gang-related activities. Dollars donated to the scholarship fund receive 100% matching funds, and more importantly, keep kids healthy, off the streets, engaged and safe.



Swim for Jenny Scholarship Fund



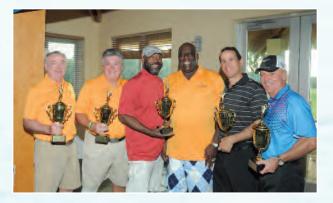

More than **50 girls**, ages 11 to 15, are inspired each year through projects, workshops and mentoring opportunities provided by Miami-Dade Parks' Girls Empowerment and Mentoring Program. The program builds self-esteem, provides quality arts experiences and strengthens the girls' connection to community.



Seniors' Walk with Ease

Launched in 2012, nearly **500 active adults**, ages 55+, are

participating in the six-week self-directed Walk with Ease Walking Program, sponsored by the Health Foundation of South Florida and Pfizer. Participants receive a guidebook with strengthening, stretching and motivational strategies.

Bicycle Safety

With support from the **Neill L. Miller Bicycle Safety Fund**, the Parks Foundation granted \$7,000 to the University of Miami's BikeSafe® program, providing nearly **700 children** with



bike safety education. The fund was established in 2009 with a generous donation by Mr.

Thomas Miller in memory of his wife, an avid bicyclist who served on the Miami-Dade County Bicycle Advisory Council.



A \$10,000 grant from the Best Buy Children's Foundation is helping to develop a computer

lab at **Gwen Cherry Park's Teen Tech Town**. The lab allows teenagers to conduct online research and take practice tests for college entrance exams.



A \$2,500 grant provided by the Christopher & Dana Reeve Foundation helped fund Miami-Dade Parks **Disability Services' Wheelchair Basketball Team's** coach, providing players the athletic development needed to compete nationally in the NWBA National Championship Tournament and Florida Conference games.

FACTS:

- Seven million children go to an empty house after school.
- A juvenile in jail costs taxpayers \$117 per day. Preventative recreation programs at Miami-Dade Parks cost as little as \$5 a day.

Did you know?

Our programming partnerships engage over 14,600 youth annually participating in youth sports at over 44 parks throughout Miami-Dade. Sports range from football to soccer to roller hockey to cheerleading.

FACTS:

• More than 300 volunteers provided 10,336 hours of service to Parks Disability Services in 2012.



Disability Services

Miami-Dade Parks' Disability Services served **860 people** with disabilities in **23 structured therapeutic recreation programs** in 2012.

Upgrades included new flooring, kitchen area improvements, cabinetry, fencing

Focus on Parks

A new program to connect youth to nature and grow environmental

stewards through photography was introduced in 2012, made possible with support from the National Park Service, Florida State Parks, HistoryMiami, the Parks Foundation and generous sponsors.





Through hands-on field trips, including this one to Everglades National Park, middle school aged children document through the lens of a camera the connections they experience at parks as they build awareness of new surroundings, and ultimately, become interested and protective of our history, culture and environment. This picture and others are part of the **Focus on Parks** travelling exhibit designed to further connect people and parks.

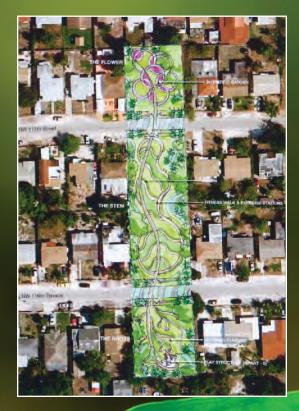
Our Projects

Partnerships with like-minded foundations, individuals, corporations and other governments have allowed the Parks Foundation and Miami-Dade Parks to improve existing facilities and develop new projects to enhance the public realm.

Gratigny Plateau Park: Making a Difference

EDSA Miller Construction Company

In a first-of-its-kind partnership, three empty lots in an underserved area of northwest Miami-Dade are being transformed into a community park with the help of corporate donors and ABC's Local 10. In line with the hit television program *Extreme Makeover: Home Edition*, the project is part of Local 10's *Making a Difference* series. Designed to resemble a flower, corporate and individual contributions are funding fitness stations, a toddler playground, park benches, a butterfly garden and more at Gratigny Plateau Park.

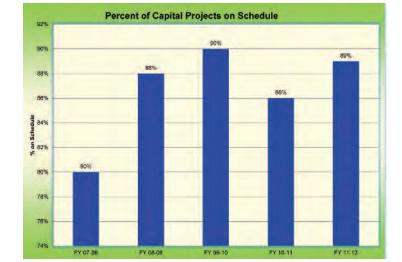

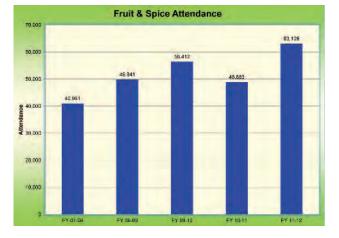
Family Adventure Challenge

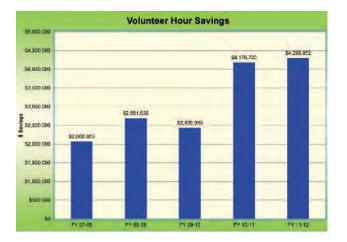
Movie Nights

The preservation, beautification and connection of parks and open spaces made significant strides in 2012, as we welcomed two new county divisions, the **Right of Way Aesthetics Management Division (RAAM) and the Community Image Advisory Board (CIAB)**.

Right of Way Aesthetics Management is charged with maintaining:

- 255 miles of medians
- 23 miles of Metrorail and Metromover
- 20 miles of busway
- 73,500 trees

The **Community Image Advisory Board** (CIAB), chaired by Miami-Dade County Commissioner Dennis Moss, leads the **Million Trees Miami** campaign which is supported by the Parks Foundation. The goal is to increase the county's tree



canopy, from **14% to 30% coverage** by the year 2020. To date the campaign has planted **104,000 trees**. CIAB Chair Dennis Moss (center right), Miami-Dade County Commissioner Barbara Jordan (right), former Miami Gardens Mayor Shirley Gibson (center left)

Greening the Community

Designer Stella McCartney, daughter of former Beatle and musician Paul McCartney, together with Bioplanet, an international reforestation organization, donated **32 native trees** to Haulover Dog Park in 2012. Bioplanet, the first supporting sponsor of Million Trees Miami, planted over 200 trees in Miami-Dade parks last year.

Currency Collection Bins

Currency Collection Bins soliciting donations from travelers for parks and animal services were installed at Miami International Airport, following legislation sponsored by Commissioner Sally Heyman. More than \$800.00 has been collected to date.



Water Conservation

Water consumption by Miami-Dade Parks is expected to be **reduced by 20-percent** through a smart metering project initiated in 2012 with IBM. Parks will be better able to monitor consumption and more quickly identify water leaks, generating up to \$1 million in savings per year.

Energy Savings

Solar panels were installed at three recreation centers in 2012. The electricity generated is expected to save \$5,000 annually.



Tobacco-Free Zones were implemented at over 40 park locations and near all playgrounds and youth ball fields in 2012

to ensure a healthier environment for all park users.

With support from the Zoological Society of Florida

(ZSF), Zoo Miami thrived in 2012. New education and conservation initiatives, coupled with record attendance, are setting the stage for a new exhibit focused on Everglades preservation, and laying the groundwork for the development of a family entertainment complex surrounding South Florida's largest attraction.

Locally and nationally recognized speakers discuss the importance of parks for improving the economy, environment and health of Miami-Dade County.

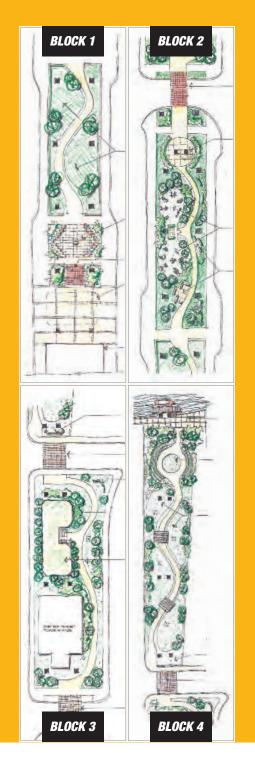


The summit's theme, *Partnerships Through Creative Initiatives: Red field to Green fields*, showcased an initiative designed to redevelop underutilized commercial land with new parks as the first phase of re-development, creating jobs and enhancing property values. Miami-Dade Parks was selected as a pilot site for the initiative, funded through a grant from the Speedwell Foundation with a local match from The John S. and James L. Knight Foundation.

Did you know?

More than **29 local municipalities**, **universities**, **state and national park agencies** are members of the **South Florida Parks Coalition**. Coalition members meet to share knowledge and expertise with the goal of creating a model park system.

Brickell Station Park



Plans are on the table to showcase the OSMP with Miami-Dade Parks' first-ever **transit-oriented park**. Located beneath Miami-Dade's above ground railway system, **Brickell Station Park** will utilize a revenue-generating app to promote local businesses and events, reduce traffic congestion and provide much-needed park land and green space for residents and visitors.



Just as New York's High Line transformed a former elevated railroad spur into a linear park, Brickell Park will make use of scarce green space beneath Miami-Dade's Metrorail as we seek to create a seamless system of beautiful connections that move residents and visitors from place to place.

Bikeways and Trails

Connecting great parks and public spaces is a major component of the OSMP. New bikeways and trails are helping us realize that vision. Construction and/or planning began on three major greenway expansion projects in 2012.

• Black Creek Trail (South-West) Extending from Larry and Penny Thompson Park to Black Point Park and Marina, the 8.7 mile Black Creek Trail is being widened, resurfaced and enhanced with additional trail segments. Amenities will include landscaping, wayfinding signage, rest areas and small shelters.



• Snake Creek Trail (North) The 4.5 mile Snake Creek Trail along Miami Gardens Drive will feature a 10-foot wide asphalt surface connecting parts of North Miami Beach, Miami Gardens and unincorporated Miami-Dade. Amenities will include two landscaped mini-parks with adult fitness stations, rubberized play climbers for tiny tots, rain shelters with single tables, benches and bicycle racks.



• River of Grass Greenway At the request of the National Park Service and with the help of a \$1.2 million grant, Miami-Dade Parks is managing the planning of the River of Grass Greenway, a 12-14 foot wide corridor through the Everglades which will extend from Miami-Dade's Krome Avenue to Naples.

Arcola Lakes Senior Center

Construction is underway on Miami-Dade County's first recreational facility specifically designed for use by senior

residents, age 55 and older. The 14,000+ square foot Arcola Lakes Senior Center will include entertainment rooms, an arts and crafts room, a ceramics room, exercise room, banquet meeting hall, therapeutic pool and more. The facility is scheduled to open in October 2013.

Ronald Reagan Equestrian Center



Miami-Dade Parks' Ronald Reagan Equestrian Center will undergo an 110,000 square foot expansion, enabling it to lure additional equestrian events. The venue, which already hosts over 36



shows a year, will be the site of the Mundial Caballos de Paso Confepaso 2013, the "World Cup" of Paso Fino events.



Florida: Mission Everglades

The diverse habitats of Florida are coming together to offer Zoo Miami visitors a new zoo experience. Set to open in 2014, the Florida: Mission Everglades exhibit and front entry plaza will showcase pine rocklands, coastal mangrove marshes, grasslands and the creatures that live within them.

Community Needs Assessment Survey

In 2013, Miami-Dade Parks will randomly sample households in neighborhoods across Miami-Dade in an effort to better understand the recreation interests and needs of residents. The survey, to be issued in three languages, will be combined with public meetings, to guide future planning, development and programming decisions.

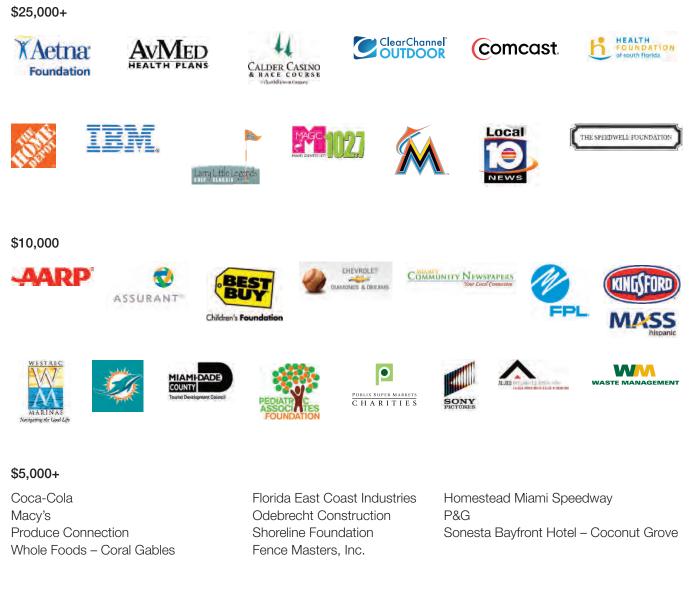

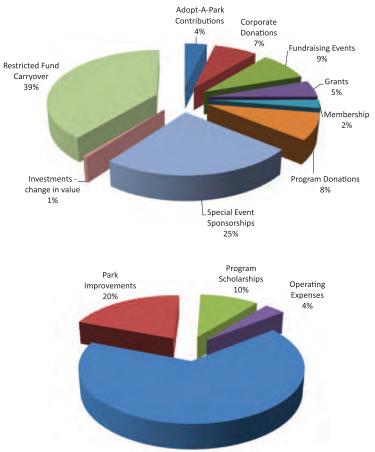

With a mission to make a real difference, the City of Muskogee Foundation was established in 2008 for the purpose of effectively developing, supporting, promoting, and improving programs and facilities relating to education, arts, culture, community revitalization and beautification, social services, health care, economic development, infrastructure, housing, and recreation for the City of Muskogee and surrounding areas and to improve the quality of life of residents of Muskogee.

The City of Muskogee Foundation funding was secured in March 2007 when Capella Healthcare entered into an agreement with the Muskogee Regional Health Center Trust Authority, a public trust, to lease Muskogee Regional Medical Center for a term of 40 years. City officials created the City of Muskogee Foundation as a nonprofit corporation from the net proceeds of this lease.

BYLAWS OF CITY OF MUSKOGEE FOUNDATION

ARTICLE I NAME AND PURPOSES

1.1 Name. The name of this Corporation is "City of Muskogee Foundation."

1.2 <u>Purposes</u>. Subject to the limitations set forth in the Certificate of Incorporation, the Corporation is formed for the purpose of effectively developing, supporting, promoting, and improving programs and facilities relating to education, arts, culture, community revitalization and beautification, social services, health care, economic development, infrastructure, housing, and recreation for the City of Muskogee (the "City") and surrounding areas and to improve the quality of life of residents of the City and surrounding areas. Subject to the foregoing, the Corporation shall have and may exercise all of the powers of nonprofit corporations under Oklahoma law.

1.3 <u>Restrictions</u>. At no time, either on dissolution or prior to dissolution, shall any part of the funds or assets of the Corporation inure to the benefit of any private individual, nor be used for the purpose of carrying on propaganda or otherwise attempting to influence legislation, except as may be permitted by law and the Internal Revenue Code of 1986, as amended, (the "Code") or corresponding provisions of any subsequent federal tax laws (all references in these Bylaws to the Code shall include reference to any corresponding provisions of any subsequent federal tax laws). The Corporation shall not participate in or intervene in any political campaign on behalf of any candidate for public office.

1.4 <u>Certain Restrictions</u>. If the Corporation is found to be a private foundation, as that term is defined in Section 509 of the Code, then (a) the Corporation shall conduct its business and distribute its income as necessary for each taxable year at such time and in such manner as not to become subject to the tax on undistributed income imposed by Section 4942 of the Code, and (b) the Corporation shall not engage in any act of self-dealing as defined in Section 4941(d) of the Code, shall not retain any excess business holdings as defined in Section 4943(c) of the Code, shall not make any investments in such a manner as to subject the Corporation to tax under Section 4944 of the Code, and shall not make any taxable expenditures as defined in Section 4945(d) of the Code.

1.5 <u>Charitable Activities</u>. The Corporation shall carry on only those activities permitted to be carried on by a charitable organization as described in Section 501(c)(3) of the Code.

2.1 <u>Principal Office</u>. The principal office of the Corporation shall be located in Muskogee, Oklahoma. The Board of Directors may establish such offices as the business of the Corporation requires.

2.2 <u>Registered Office</u>. The Corporation shall have and continuously maintain a registered office in Oklahoma and a registered agent whose office is the same as the registered office.

ARTICLE III SOLE MEMBER

3.1 <u>Sole Member</u>. The sole member of the Corporation is the City.

3.2 <u>Rights of Member</u>. The City, as sole member of the Corporation, shall be eligible and authorized to vote, to furnish any necessary consent or approval, or to take other action on any issue that may properly be presented to the City as the member of the Corporation. The City must approve the following matters:

(a) any amendment, restatement, or repeal of the Certificate of Incorporation of the Corporation or these Bylaws;

(b) the election or appointment of directors of the Corporation;

(c) the merger or consolidation of the Corporation with or into any other entity, enterprise, agency, or body; the sale of all or substantially all of the assets of the Corporation; or the acquisition of the Corporation by any other entity or enterprise;

(d) the dissolution, liquidation, or termination of the business of the Corporation;

(e) a change in the purposes of the Corporation;

(f) any decision to file a voluntary petition under any law having for its purpose the adjudication of the Corporation as bankrupt or insolvent or the taking any action with respect to the reorganization or liquidation of the Corporation;

- (g) the selection of the Chairman of the Board of the Corporation; and
- (h) the selection of the independent auditors.

3.3 <u>Meetings</u>. The City, as the sole member of the Corporation, may hold meetings as it determines appropriate.

ARTICLE IV BOARD OF DIRECTORS

4.1 <u>Powers</u>. The Board of Directors shall manage and direct the business and affairs of the Corporation. The directors shall have all powers and authority provided in the Certificate of Incorporation and permitted by law.

4.2 <u>Number: Qualifications</u>. The number of directors that will constitute the entire Board of Directors shall be not less than three or more than 15, as determined by the Muskogee City Council (the Council"). Initially, the Board shall be comprised of 13 directors. Two of the members of the Board of Directors shall be the Mayor of the City of Muskogee and the City Manager of the City of Muskogee, who shall serve as voting members of the Board of Directors. The Council shall also designate two members of the Council to serve as voting members of the Board of Directors. The Council shall appoint the remaining members of the Board of Directors from a list of candidates who are not members of the Council, nominated by members of the Council. Each member of the Council may nominate three candidates within time frames and in accordance with procedures established by the Mayor of the City of Muskogee.

Terms. The Mayor may serve as a director as long as he or she serves as Mayor 4.3 of the City of Muskogee. The City Manager may serve as a director as long as he or she serves as City Manager of the City of Muskogee. The two members of the Council may each serve as a director for a full term of two years, but shall then not be eligible to serve as a director for a period of at least one year. A member of the Council who is elected to serve as a director may not continue to serve as a director if he or she no longer serves as a member of the Council. The remaining directors shall be divided into three classes, as nearly as equal in number as possible. Directors of the first class will hold office for a term expiring at the annual meeting in 2012; directors of the second class will hold office for a term expiring at the annual meeting in 2013; and directors of the third class will hold office for a term expiring at the annual meeting in 2014. Subject to the foregoing, the successors to the class of directors whose term shall then expire shall be elected to hold office for a term expiring at the sixth succeeding annual meeting and until his or her successor has been duly elected and has qualified. The directors serving in classes may be elected to serve for one full term, but shall then not be eligible to serve as a director for a period of at least one year.

4.4 <u>Vacancies</u>. If a vacancy results from the resignation, removal, or other inability or incapacity of a director, other than the Mayor or City Manager of the City of Muskogee, then the Council may fill the vacancy. A director so chosen shall be elected to serve for the remainder of the term of the director whose position had become vacant; any partial term shall not limit the eligibility of the director to serve one full term. If a vacancy results from the resignation, removal, or other inability or incapacity of the Mayor or City Manager, then the successor in office as Mayor or City Manager, as the case may be, shall serve as a director as provided in these Bylaws.

4.5 <u>Removal: Resignation</u>. The Council may remove any director with or without cause by a majority vote of the entire Council. If a director attends fewer than 50% of the Board meetings held during any 12-month period, the Council may evaluate the director's participation

and the reasons for excessive absence and may consider the director's excessive absence as good cause for removal. A director may resign by submitting a notice of resignation in writing to the Council. The resignation is effective upon receipt, unless otherwise stated in the notice.

4.6 <u>Advisory Directors</u>. Advisory Directors shall include the Executive Director of Muskogee Development, the Executive Director of the Greater Muskogee Area Chamber of Commerce, the President of the Muskogee Education Consortium, the Executive Director of the Lake Area United Way, and the Executive Director of the Muskogee Nonprofit Resource Center. The Board of Directors may appoint additional individuals to serve as Advisory Directors. Advisory Directors may attend meetings of the Board of Directors and serve as members of committees, other than the Executive Committee, but they may not vote as directors, serve as officers, or be counted in determining whether a quorum is present at meetings of the Board of Directors.

4.7 <u>Regular Meetings</u>. The Board shall hold an annual meeting during the first quarter following the end of each fiscal year of the Corporation for the purpose of electing officers and transacting any other business that may properly come before the meeting. The Board may hold additional regular meetings without call or notice at such place and time as the Board may determine.

4.8 <u>Special Meetings</u>. The Chairman of the Board or a majority of directors then in office may call special meetings. Notice of a special meeting shall be given to each director at least seven days before the meeting. The notice shall set forth the time and place of the meeting but need not, unless otherwise required by law, state the purposes of the meeting. A majority of the directors present at any meeting may adjourn the meeting without notice, other than an announcement at the meeting.

4.9 <u>Place of Meetings</u>. Board meetings may be held at such places as the Board may determine or as may be specified in the notice of the meeting.

4.10 <u>Open Meetings Act</u>. Meetings of the Board of Directors and Executive Committee of the Corporation shall be conducted in accordance with the requirements of the Oklahoma Open Meetings Act. In the event of a conflict between the provisions of these Bylaws and the Open Meetings Act, the Open Meetings Act shall control.

4.11 <u>Quorum and Voting</u>. A majority of the total number of directors, excluding any vacancies, present in person, shall constitute a quorum for the transaction of business at any meeting of the Board. Each director shall be entitled to one vote on matters presented to the directors. Board members may not vote by proxy. Except as otherwise specified in these Bylaws, the act of a majority of directors present in person at a meeting at which a quorum is present shall be the act of the Board of Directors.

4.12 <u>Presence at Meeting</u>. Members of the Board of Directors or of any Board committee may participate in a meeting of the Board or committee by means of conference telephone or similar communications equipment, provided that all directors participating in the

meeting can hear each other. Such participation shall be considered to be presence in person at the meeting.

4.13 <u>Action Without Meeting</u>. Any action required or permitted to be taken at any meeting of the Board of Directors or of any Board committee may be taken without a meeting if all members of the Board or such committee, as the case may be, consent to the action in writing, and the written consent is filed with the minutes of the proceedings of the Board or committee.

4.14 <u>Compensation</u>. The Corporation shall not pay any stated compensation to directors for their services as directors. Upon resolution of the Board, the Corporation may reimburse directors for the actual and reasonable expenses incurred in attending any meeting of the Board or of any committee.

ARTICLE V OFFICERS AND EMPLOYEES

5.1 <u>Election</u>. At each annual meeting of the Board of Directors, the Board of Directors shall elect such officers of the Corporation as may be necessary to enable the Corporation to sign instruments that comply with the Oklahoma General Corporation Act. Officers may include a Chairman of the Board, one or more Vice Chairs, a Secretary, an Assistant Secretary, and a Treasurer. The Board of Directors may also select or appoint an Executive Director of the Corporation.

5.2 <u>Terms, Removal and Vacancies</u>. The officers shall hold office for a term of one year and until their successors are duly elected and qualified and shall serve at the pleasure of the Board. The Board may remove any officer at any time whenever in its judgment removal would serve the best interests of the Corporation. The Board of Directors shall fill a vacancy in any office.

5.3 <u>Chairman of the Board</u>. The Chairman of the Board shall be subject to the direction of the Board of Directors and shall perform such duties as may be assigned by the Board. The Chairman of the Board shall preside at all meetings of the Board of Directors. The responsibilities of the Chairman of the Board shall include acting as a representative of the Corporation to the public as well as to governmental and voluntary organizations. The Chairman of the Board shall have authority to execute deeds, mortgages, leases, and contracts or other instruments of the Corporation, except where the signing and execution are expressly delegated by the Board of Directors or by the Chairman of the Board to some other officer or agent of the Corporation. In addition, the Chairman of the Board shall in general have such authority and perform all other duties incident to the position of Chairman of the Board of a nonprofit corporation.

5.4 <u>Vice Chair</u>. The Vice Chair shall perform such duties as the Board of Directors or the Chairman of the Board may assign. In the absence or inability to act of the Chairman of the Board, the Vice Chair shall perform the duties and discharge the responsibilities of the Chairman of the Board.

5.5 <u>Secretary and Assistant Secretary</u>. The Secretary shall keep corporate records and shall give notice of, attend, and record minutes of meetings of members and directors. The Secretary shall, in general, perform all duties incident to the office of secretary and such other duties as the Board of Directors or the Chairman of the Board may assign. The Secretary may delegate any such duties to an Assistant Secretary.

5.6 <u>Treasurer</u>. The Treasurer shall be responsible for developing budgets and reporting to the Board on the financial affairs of the Corporation. The Treasurer shall also perform such duties as the Board of Directors or the Chairman of the Board may assign.

5.7 Executive Director. The Board may appoint an Executive Director of the Corporation. If appointed, the Executive Director shall (a) have the overall supervision of the business of the Corporation and shall direct the affairs and policies of the Corporation, subject to any directions that may be given by the Board of Directors or the Chairman of the Board: (b) assure that the Corporation conforms with the requirements of authorized regulatory authorities; (c) oversee compliance with the laws and regulations of federal, state and local governmental authorities: (d) carry out all policies and procedures established by the Board of Directors; and (e) in general, perform all other duties incident to the position of chief management, administrative, and operating officer of a corporation and have such authority and responsibilities as may be prescribed by the Board of Directors. The responsibilities of the Executive Director shall include acting as a representative of the Corporation to the public and to governmental and voluntary organizations and reporting to the Board of Directors on the performance of corporate functions. The Executive Director, in addition to the Chairman of the Board, shall have authority to execute deeds, mortgages, leases, contracts, or other instruments of the Corporation to the extent authorized by the Board of Directors, except where the signing and execution are expressly delegated by the Board of Directors to some other officer or agent of the Corporation. The Board of Directors may determine the compensation of the Executive Director and shall periodically evaluate the performance of the Executive Director.

ARTICLE VI COMMITTEES

6.1 <u>Appointment of Members</u>. The Chairman of the Board shall appoint members and Chairs of all committees, other than the Executive Committee. Each committee may consist of one or more directors of the Corporation and shall have such name or designation as the Board may determine. The Chairman of the Board may designate one or more directors as alternate members of any committee who may replace any absent or disqualified member at any meeting of the committee. Any committee, to the extent authorized by the Board, shall have and may exercise the authority of the Board of Directors in the management of the business and affairs of the Corporation and may generally perform duties and exercise authority as may be directed or delegated by the Board of Directors. Each committee shall regularly report to the Board of Directors. The Chairman of the Board may appoint individuals who are not directors to serve as members of a committee, other than the Executive Committee, as long as the Board has not delegated its powers and authority to that committee. 6.2 <u>Executive Committee</u>. The Executive Committee shall consist of the officers of the Corporation who are directors. Additionally, the Executive Director of the Corporation shall serve as an ex officio member of the Executive Committee, without vote. The Executive Committee may meet at stated times or on notice to all of its members. During intervals between meetings of the Board of Directors, the Executive Committee shall generally perform such duties and exercise such powers as may be directed or delegated by the Board of Directors. The Board of Directors may delegate to the Executive Committee authority to exercise all of the powers of the Board.

6.3 <u>Investment Committee</u>. The Investment Committee shall be responsible for overseeing the management of the assets, funds, and investments of the Corporation. Among other matters, the Investment Committee shall (a) recommend investment advisors, investment managers, and funds managers to the Board of Directors, (b) meet periodically with, and receive regular and periodic reports from, the investment advisors, investment managers, and funds managers regarding the investment of funds of the Corporation, (c) establish investment policies for the prudent management of the assets, funds, and investments of the Corporation, (d) periodically evaluate the performance of the Corporation's investment advisors, investment managers, and funds managers based on standards and criteria established by the committee, and (e) report to the Board regarding the affairs of the committee and the investments of the Corporation.

6.4 Grants Committees. The Grants Committees shall be responsible for administration of grants. The current Grants Committees are the Economic Development Committee, the Education Committee, the Health and Wellness Committee, and the Opportunities Committee. Among other matters, each Grants Committee, with respect to the administration of those grants falling within the subject matter of each committee, shall (a) recommend to the Board of Directors criteria for awarding grants and for recipients of grants, including criteria relating to one-time and multi-year grants, awards of multiple grants to the same entity, award of scholarships or other grants to individuals, and grants relating to municipal operations, (b) develop and implement policies and procedures relating to grant applications, including processing of grant applications, grant cycles, and a schedule or calendar pertaining to submission, processing, review, approval, and award of grants, (c) evaluate grant applications submitted to the Corporation and make recommendations with respect to the award of grants, including amounts, conditions, and requirements, (d) develop agreements relating to grants awarded by the Corporation, (e) establish policies and procedures relating to reporting by grant recipients, as well as accounting and expenditure responsibility obligations of grant recipients, and (f) generally administer the grants process of the Corporation. The Economic Development Committee may, in its discretion, consider grants for economic development at any time within or outside of the established grant cycle. Any grant awarded upon the recommendation of the Economic Development Committee may or may not, in the discretion of the Board of Directors, affect the granting budget of the Corporation. All decisions as to the final selection of grant recipients and award of grants by the Corporation shall be reserved to the Board of Directors.

6.5 <u>Term</u>. Each member of a committee shall continue as a member until the next annual meeting and until a successor is appointed, unless the committee to which the member

belongs is discontinued by the Board of Directors or unless the member dies, resigns, or is removed as a committee member.

6.6 <u>Committee Meetings</u>. Committee meetings may be held at such places as each committee may determine or as may be specified in the call of any meetings. The Chair of the committee shall arrange for written notice of the time and place of the meeting to be given to members of the committee. Business to be transacted at any regular meeting of the committees shall not be limited to the matters set forth in the notice of meeting. The attendance of any committee member at any meeting shall constitute a waiver of notice of the meeting.

6.7 <u>Quorum</u>. A majority of the committee members present in person shall constitute a quorum for the transaction of business at any meeting of the committee.

6.8 <u>Action Without Meeting</u>. Any action required or permitted to be taken at any meeting of any Board committee may be taken without a meeting if a majority of the members of the committee consent to the action in writing, and the written consent is filed with the minutes of the proceedings of the committee.

6.9 <u>Vacancies</u>. The Chairman of the Board shall appoint persons to fill vacancies on committees resulting from the resignation, removal, or other inability or incapacity of a member. A member so appointed shall serve for the remainder of the unexpired term.

ARTICLE VII INDEMNIFICATION OF DIRECTORS, OFFICERS, EMPLOYEES AND AGENTS

7.1 Actions Other Than in the Right of the Corporation. The Corporation shall indemnify any person who was or is a party or is threatened to be made a party to any threatened, pending or completed action, suit, or proceeding whether civil, criminal, administrative, or investigative (other than an action by or in the right of the Corporation) by reason of the fact that he or she is or was a director, officer, employee, or agent of the Corporation or is or was serving at the request of the Corporation as a director, trustee, officer, manager, employee, or agent of another corporation, limited liability company, partnership, joint venture, or other enterprise against expenses (including attorney's fees), judgments, fines, and amounts paid in settlement actually and reasonably incurred in connection with such action, suit, or proceeding if such person acted in good faith and in a manner he or she reasonably believed to be in or not opposed to the best interest of the Corporation and, with respect to any criminal action or proceeding, had no reasonable cause to believe that his or her conduct was unlawful. The termination of any action, suit, or proceeding by judgment, order, settlement, conviction, or upon a plea of nolo contendere or its equivalent shall not of itself create a presumption that the person did not act in good faith and in a manner that such person reasonably believed to be in good faith and in a manner that he or she reasonably believed to be in or not opposed to the best interest of the Corporation and with respect to any criminal action or proceeding had reasonable cause to believe that his or her conduct was unlawful.

7.2 <u>Actions by or in the Right of the Corporation</u>. The Corporation shall indemnify any person who was or is a party or is threatened to be made a party to any threatened, pending or completed action or suit by or in the right of the Corporation to procure a judgment in its favor by reason of the fact that such person is or was a director, officer, employee, or agent of the Corporation or is or was serving at the request of the Corporation as a director, trustee, officer, manager, employee, or agent of another corporation, limited liability company, partnership, joint venture, trust, or other enterprise against expenses (including attorney's fees) actually and reasonably incurred in connection with the defense or settlement of such action or suit if such person acted in good faith and in a manner he or she reasonably believed to be in or not opposed to the best interest of the Corporation; except that no indemnification shall be made in respect of any claim, issue or matter as to which such person shall have been adjudged to be liable to the Corporation unless and only to the extent that the court in which such action or suit was brought shall determine, upon application, that despite the adjudication of liability, but in the view of all the circumstances of the case, such person is fairly and reasonably entitled to indemnity for such expenses that the court shall deem proper.

7.3 <u>Advancement of Expenses</u>. Expenses incurred in defending a civil or criminal action, suit, or proceeding, in advance of the final disposition of such action, suit, or proceeding upon receipt of an undertaking by or on behalf of the director, officer, employee, or agent to repay such amount if it is ultimately be determined that he or she is not entitled to be indemnified by the Corporation.

7.4 <u>Insurance</u>. The Corporation may purchase (upon resolution duly adopted by the Board of Directors) and maintain insurance on behalf of any person who is or was a director, officer, employee, or agent of the Corporation, or is or was serving at the request of the Corporation as a director, trustee, manager, officer, employee or agent of another corporation, limited liability company, partnership, joint venture, trust, or other enterprise against any liability asserted against such person and incurred in any such capacity, or arising out of his or her status as such, whether or not the Corporation would have the power to indemnify such person against such liability.

7.5 <u>Indemnification Required</u>. To the extent that a director, officer, employee, or agent of the Corporation has been successful on the merits or otherwise in defense of any action, suit, or proceeding referred to in this article or in defense of any claim, issue, or other matter, such person shall be indemnified against expenses (including attorneys' fees) actually and reasonably incurred in connection with the matter.

7.6 <u>Entitlement</u>. Every such person shall be entitled, without demand upon the Corporation or any action by the Corporation, to enforce his or her right to such indemnity in an action at law against the Corporation. The right of indemnification and advancement of expenses provided in this Article shall not be deemed exclusive of any rights to which any such person may now or later be otherwise entitled. Without limiting the generality of the foregoing, the right to indemnity shall not be deemed exclusive of any rights pursuant to statute or otherwise, of any such person in any action, suit, or proceeding to have assessed or allowed in his or her favor against the Corporation or otherwise, costs and expenses incurred in connection with the matter.

ARTICLE VIII

INTERESTED PARTIES

8.1 <u>Definitions</u>.

(a) <u>Interested Person</u>. Any director or officer who has a material direct or indirect financial interest, as defined in this Article, is an interested person.

(b) <u>Financial Interest</u>. A person has a financial interest if the person has, directly or indirectly, through business, investment, or family: (i) a material ownership or investment interest in any entity with which the Corporation has a transaction or arrangement; or (ii) a material compensation arrangement with the Corporation or with any entity or individual with which the Corporation has a transaction or arrangement. A person shall not be deemed to have a "financial interest" due to an employment arrangement with, or serving as a director or officer of, another nonprofit organization that is exempt from federal income taxation under the Code.

8.2 <u>Disclosure</u>. An Interested Person shall disclose to the directors the existence and nature of his or her financial interest in any proposed transaction or arrangement involving the Corporation.

8.3 Procedures for Addressing Conflicts of Interest. The Chairman of the Board or the Chair of a committee considering a transaction or arrangement involving an Interested Person shall, if appropriate, appoint a disinterested person or committee to investigate alternatives to the proposed transaction or arrangement. The members of the Board or committee shall determine whether, in their judgment, the transaction or arrangement is fair to the Corporation. They may also evaluate whether the Corporation may, without undue burden, delay or expense, obtain a more advantageous transaction or arrangement with reasonable efforts from a person or entity that would not give rise to a conflict of interest. In evaluating whether a transaction or arrangement is more advantageous, the members of the Board or committee, as the case may be, may take into account all facts and circumstances that they reasonably believe to be appropriate in their judgment, including factors relating to price, cost, quality, compensation arrangements, financial arrangements, capability, capacity, convenience to the organization, historical relationships, production efficiencies, market efficiencies, community interests, organizational support, reputation, availability, responsiveness, experience, location. commercial reasonableness, fair market value, market conditions, timing, scheduling, or other appropriate factors, depending on the nature of the transaction or arrangement. The Board, the committee, or the Corporation shall determine, by a majority vote of the disinterested directors, whether the transaction or arrangement is in the best interest of the Corporation, and they may pursue and approve the transaction or arrangement, as long as they reasonably believe in good faith that the transaction or arrangement is fair to the Corporation.

8.4 <u>Violations</u>. If the Board or committee has reasonable cause to believe that an Interested Person has failed to disclose a conflict of interest as required in this Article, the Board or committee shall inform the Interested Person of the basis for such belief and afford the Interested Person an opportunity to explain the alleged failure to disclose. If, after hearing the response of the Interested Person and making such further investigation as may be warranted in

the circumstances, the Board or committee determines that the Interested Person has in fact failed to disclose a conflict of interest as required in this Article, the Board or committee shall take appropriate disciplinary and corrective action.

8.5 <u>Record of Proceedings</u>. The minutes of the Board or committee shall contain: (a) the names of the persons who disclosed or otherwise were found to have a financial interest in connection with a conflict of interest, the nature of the financial interest, any action taken to determine whether a conflict of interest was present, and the decision as to whether a conflict of interest in fact existed, and (b) the names of the persons who were present for discussions and votes relating to the transaction or arrangement, and a record of any votes taken.

8.6 <u>Compensation</u>. A director or committee member who receives compensation or remuneration, directly or indirectly, from the Corporation shall not vote on matters pertaining to his or her compensation.

8.7 <u>Validation of Contracts</u>. No contract or transaction between the Corporation and one or more of its directors or officers, or between the Corporation and any other organization in which one or more of its directors or officers serve as directors, officers, or members or have a financial interest shall be void or voidable solely for this reason or solely because the director or officer is present at or participates in the meeting of the Board where the contract or transaction is authorized or approved or solely because his or her vote is counted for such purposes if:

(a) The material facts as to the director's interest and as to the contract or transaction are disclosed or are known to the Board of Directors, and the Board in good faith authorizes the contract or transaction by a vote sufficient for such purpose without counting the vote of the interested directors; or

(b) The contract or transaction is fair as to the Corporation as of the time it is authorized, approved, or ratified by the Board of Directors.

8.8 <u>Quorum</u>. Interested directors may be counted in determining the presence of a quorum at a meeting at which the Board of Directors authorizes the contract or transaction.

ARTICLE IX GENERAL PROVISIONS

9.1 <u>Notices</u>. Unless otherwise provided by these Bylaws, notice may be given in writing and delivered personally, sent by United States mail postage paid, by FAX, or by electronic mail, and addressed to the individual to whom notice is being given at such address as appears on the records of the Corporation.

9.2 <u>Waiver of Notice</u>. A person entitled to receive notice under these Bylaws may waive the notice requirement by executing a written waiver.

9.3 <u>Policy Against Discrimination</u>. The Corporation shall not exclude from participation, deny benefits or services, or discriminate against any individual, on the basis of

race, color, national origin, religion, sex, physical disability, or impairment in any program or activity it sponsors or conducts.

9.4 <u>No Implied Rights</u>. Nothing contained in these Bylaws is intended to confer any rights or benefits upon any individual or to confer any private right, remedy, or right of action upon any person. These Bylaws are intended for internal corporate use only and solely for the governance of the internal affairs of the Corporation.

9.5 <u>Immunities</u>. To the fullest extent permitted by law, directors shall not be liable in damages to the Corporation or any member for breach of fiduciary duty as a director.

ARTICLE X <u>AMENDMENTS</u>

These Bylaws may be amended, repealed, restated, or new bylaws may be adopted in the manner provided in the Certificate of Incorporation or the Oklahoma General Corporation Act.

ARTICLE I NAME AND PURPOSES

SECTION 4. REGISTERED AGENT. The City Manager of the City of Doral shall be the registered agent for the Corporation.

ARTICLE II MEMBERS

The Corporation shall have no members.

ARTICLE III BOARD OF DIRECTORS

SECTION 1. GENERAL POWERS. Except as set forth herein, the affairs of the Corporation shall be managed by or under the direction of its Board of Directors (hereinafter, the "Board"). The Board shall elect its own officers and adopt rules of procedure.

SECTION 2. NUMBER, TENURE AND QUALIFICATIONS AND DUTIES. The Board shall consist of not less than one (1) or more than five (5) persons. Each Director shall serve for a term of one (1) year. Pursuant to Section 2.02(iv) of the City Charter, the Mayor of the City of Doral shall appoint all members of the Board subject to the approval of the City Council. SECTION 3. RESIGNATION AND REMOVAL. A Director may resign at any time by providing notice to the Secretary in writing. A Director may be removed by a 4/5 vote of the Board after determining that the Director is not contributing positively to the mission of the Corporation or by a majority vote of the City Council. Any Director who, without being excused by the Board President, misses three (3) consecutive meetings shall be deemed to have resigned.

SECTION 4. REGULAR MEETINGS. The annual meeting shall be held during the fall at which time Directors and Officers up for election shall be elected. Elected terms will correspond to the calendar year. Meetings of the Board shall be held at least quarterly.

SECTION 5. SPECIAL MEETINGS. Special meetings of the Board may be called by the Secretary at the request of the President or Directors constituting 3/5 or more of the Board members.

SECTION 6. NOTICE. Notice of the annual meeting and any regular meeting of the Board and any committee thereof, shall be given at least five (5) days previous thereto by written notice delivered to each Director at his or her physical or email address as shown on the records of the Corporation. Special meetings may be called upon at least twenty-four (24) hours notice delivered by telephone, confirmed facsimile, confirmed email, hand delivery or overnight delivery by an overnight courier service with a reputable delivery tracking system.

SECTION 7. QUORUM. 3/5 of the Directors must be present in person in order to constitute a quorum for the transaction of business at any meeting of the Board. If less than a quorum is present the meeting may adjourn without further notice.

SECTION 8. ELECTRONIC PARTICIPATION. The Board, or any committee thereof, may participate in and act at any meeting through the use of a conference telephone or other communications equipment, including computers, by means of which all persons participating in the meeting can communicate with each other. Participation in such meeting shall constitute attendance at the meeting and but shall not be counted as part of the quorum.

SECTION 9. MANNER OF ACTING. The act of a majority of the Directors present at a meeting at which a quorum is present shall be the act of the Board, unless the act of a greater number is required by statute or these Bylaws. No Director may act by proxy on any matter.

SECTION 10. INFORMAL ACTION BY DIRECTORS. The authority of the Board, or any committee thereof, may be exercised without a meeting if a written consent, setting forth the action taken, is signed by a majority (or such greater number if required by law or these Bylaws) of the Directors.

SECTION 11. COMPENSATION. The elected Directors shall not receive any compensation for serving on the Board and shall not become a paid officer, agent, or employee of the Corporation while a member of the Board.

ARTICLE IV OFFICERS

SECTION 1. OFFICERS. The Officers of the Corporation shall be a President, Vice President, Secretary, Treasurer and such other officers as may be elected or appointed by the Board from among the members of the Board. Officers whose authority and duties are not prescribed in these Bylaws shall have the authority and perform the duties prescribed by the Board.

SECTION 2. ELECTION AND TERM OF OFFICE. The Officers of the Corporation shall be elected at the Annual Meeting of the Board. Terms of office will correspond to the calendar year. All elected Officers shall hold office for a period of one year unless they resign or are removed by the Board earlier.

SECTION 3. RESIGNATION AND REMOVAL OF OFFICERS. Any Officer elected or appointed by the Board may be removed by the Board whenever in its judgment the best interests of the Corporation would be served thereby. Any Officer may resign at any time upon written notice to the Board President.

SECTION 4. EXECUTIVE DIRECTOR. The Executive Director, if one is appointed by the Board, shall report to the Corporation Board and be responsible for the day to day operations of the Corporation and implementing the directives established by the Board.

SECTION 5. PRESIDENT OF THE BOARD. The President of the Board shall preside at all regular and special meetings of the Board. The President shall perform such other duties as are required by the Board. The President shall also serve as an ex-officio member of each standing committee that may be created.

SECTION 6. SECRETARY. The Secretary shall record the minutes of the meetings of the Board; see that all notices are duly given in accordance with the provisions of these Bylaws or as required by law; be custodian of the corporate records; and perform all duties incident to the office of secretary.

SECTION 7. TREASURER. The Treasurer shall be responsible for monitoring the financial reports of the Corporation and making sure that corporate limits are maintained. The Treasurer shall report at every regular meeting of the Board on the Corporation's financial status.

ARTICLE V CONTRACTS, CHECKS, DEPOSITS AND GIFTS

SECTION 1. CONTRACTS. The Board may authorize any officer or agent of the Corporation to enter into any contract or execute and deliver any instrument in the name of and on behalf of the Corporation, and such authority may be general or confined to specific instances.

SECTION 2. CHECKS, DRAFTS, ETC. All checks, drafts or other orders for the payment of money, notes or other evidences of indebtedness issued in the name of the Corporation shall be signed by such officer or officers or agent or agents of the Corporation and in such manner as shall from time to time be determined by resolution of the Board.

SECTION 3. DEPOSITS. All funds of the Corporation shall be deposited from time to time to the credit of the Corporation in such banks, trust companies or other depositories as the Board may designate.

SECTION 4. GIFTS. The Board may accept on behalf of the Corporation any contribution, gift, bequest or devise for the general purposes or for any special purpose of the Corporation.

ARTICLE VI FISCAL YEAR

The fiscal year of the Corporation shall begin October 1 and end on September 30 of each year.

ARTICLE VII AMENDMENTS

The Board may propose and adopt amendments to these Bylaws.

Participation in such meeting shall constitute attendance at the meeting and but shall not be counted as part of the quorum.

SECTION 9. MANNER OF ACTING. The act of a majority of the Directors present at a meeting at which a quorum is present shall be the act of the Board, unless the act of a greater number is required by statute or these Bylaws. No Director may act by proxy on any matter.

SECTION 10. INFORMAL ACTION BY DIRECTORS. The authority of the Board, or any committee thereof, may be exercised without a meeting if a written consent, setting forth the action taken, is signed by a majority (or such greater number if required by law or these Bylaws) of the Directors.

SECTION 11. COMPENSATION. The elected Directors shall not receive any compensation for serving on the Board and shall not become a paid officer, agent, or employee of the Corporation while a member of the Board.

ARTICLE IV OFFICERS

SECTION 1. OFFICERS. The Officers of the Corporation shall be a President, Vice President, Secretary, Treasurer and such other officers as may be elected or appointed by the Board from among the members of the Board. Officers whose authority and duties are not prescribed in these Bylaws shall have the authority and perform the duties prescribed by the Board.

SECTION 2. ELECTION AND TERM OF OFFICE. The Officers of the Corporation shall be elected at the Annual Meeting of the Board. Terms of office will correspond to the calendar year. All elected Officers shall hold office for a period of one year unless they resign or are removed by the Board earlier.

SECTION 3. RESIGNATION AND REMOVAL OF OFFICERS. Any Officer elected or appointed by the Board may be removed by the Board whenever in its judgment the best interests of the Corporation would be served thereby. Any Officer may resign at any time upon written notice to the Board President.

SECTION 4. EXECUTIVE DIRECTOR. The Executive Director, if one is appointed by the Board, shall report to the Corporation Board and be responsible for the day to day operations of the Corporation and implementing the directives established by the Board.

SECTION 5. PRESIDENT OF THE BOARD. The President of the Board shall preside at all regular and special meetings of the Board. The President shall perform such other duties as are required by the Board. The President shall also serve as an ex-officio member of each standing committee that may be created.

SECTION 6. SECRETARY. The Secretary shall record the minutes of the meetings of the Board; see that all notices are duly given in accordance with the provisions of these Bylaws or as required by law; be custodian of the corporate records; and perform all duties incident to the office of secretary.

SECTION 7. TREASURER. The Treasurer shall be responsible for monitoring the financial reports of the Corporation and making sure that corporate limits are maintained. The Treasurer shall report at every regular meeting of the Board on the Corporation's financial status.

ARTICLE V CONTRACTS, CHECKS, DEPOSITS AND GIFTS

SECTION 1. CONTRACTS. The Board may authorize any officer or agent of the Corporation to enter into any contract or execute and deliver any instrument in the name of and on behalf of the Corporation, and such authority may be general or confined to specific instances.

SECTION 2. CHECKS, DRAFTS, ETC. All checks, drafts or other orders for the payment of money, notes or other evidences of indebtedness issued in the name of the Corporation shall be signed by such officer or officers or agent or agents of the Corporation and in such manner as shall from time to time be determined by resolution of the Board.

SECTION 3. DEPOSITS. All funds of the Corporation shall be deposited from time to time to the credit of the Corporation in such banks, trust companies or other depositories as the Board may designate.

SECTION 4. GIFTS. The Board may accept on behalf of the Corporation any contribution, gift, bequest or devise for the general purposes or for any special purpose of the Corporation.

ARTICLE VI FISCAL YEAR

The fiscal year of the Corporation shall begin October 1 and end on September 30 of each year.

ARTICLE VII AMENDMENTS

The Board may propose and adopt amendments to these Bylaws.
