

**RESOLUTION No. 19-304**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AWARDED REQUEST FOR PROPOSALS #2019-39 "RECREATIONAL BEACH TENNIS PROGRAM MANAGEMENT" TO THE TOP RANKED FIRM AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH DORAL BEACH TENNIS CLUB LLC. FOR THE PROVISION OF RECREATIONAL BEACH TENNIS PROGRAMMING FOR AN INITIAL PERIOD OF TWO (2) YEARS WITH THE OPTION TO RENEW FOR AN ADDITIONAL TWO (2) ONE (1) YEAR PERIODS FOR A TOTAL OF FOUR (4) YEARS; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH THE SECOND RANKED FIRM IF AN AGREEMENT CANNOT BE REACHED WITH THE TOP RANKED FIRM; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, On September 30, 2019, the City advertised Request for Proposals # 2019-39 "Recreational Beach Tennis Program Management" for the provision of providing Recreational Beach Tennis Programming for the City of Doral.

**WHEREAS**, Two (2) firms attended the mandatory pre-bid meeting on October 15, 2019. Two (2) submittals were received and opened on October 31, 2019, with all firms meeting the required criteria set forth in the Request for Proposals; and

**WHEREAS**, On November 14, 2019, the evaluation committee scored and ranked the submittals based on a three-hundred point (300) scale.

**WHEREAS**, Staff respectfully requests City Council approval to authorize the City Manager to negotiate and enter into an agreement with Doral Beach Tennis Club LLC. for the provision of providing recreational beach tennis programming for an initial period of two (2) years with the option to renew for two (2) one (1) years for a total of four (4) years. Staff further requests approval from the Mayor and City Council-members to authorize the City Manager to negotiate and enter into an agreement with the second ranked firm if an agreement cannot be reached with Doral Beach Tennis Club LLC. The provider will be

responsible for accepting registrations and paying the City the agreed upon revenue percentage of twenty-five to thirty (25%-30%) percent which will be deposited into account 001.9000.347200 (Recreation- Recreation Fees).

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval & Authorization.** The City Council hereby approves the award of RFP # 2019-39 to the top ranked firms and authorizes the City Manager to negotiate and enter into an agreement with Doral Beach Tennis Club LLC. for the provision of providing recreational beach tennis programming for an initial period of two (2) years with the option to renew for two (2) one (1) years for a total of four (4) years. The Mayor and City Council-members further approve and authorize the City Manager to negotiate and enter into an agreement with the second ranked firm if an agreement cannot be reached with Doral Beach Tennis Club LLC. The provider will be responsible for accepting registrations and paying the City the agreed upon revenue percentage of twenty-five to thirty (25%-30%) percent which will be deposited into account 001.9000.347200 (Recreation- Recreation Fees). The agreement is subject to approval by the City Attorney as to form and legal sufficiency and on such other terms and conditions as may be appropriate to protect and further the interest of the City. This Authorization does not create or confer any rights to Doral Beach Tennis Club LLC or any of the other ranked firms.

**Section 3. Implementation.** The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

**Section 4. Effective Date.** This resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Councilmember Mariaca who moved its adoption. The motion was seconded by Councilmember Cabrera and upon being put to a vote, the vote was as follows:
