

**RESOLUTION No. 20-24**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING AN SPECIAL EVENT PERMIT FOR NATIONAL KIDNEY FOUNDATION OF FLORIDA TO HOST THE “2020 DORAL KIDNEY WALK” EVENT AT DORAL CENTRAL PARK LOCATED AT 3000 NW 87 AVENUE DORAL, FL 33172, ON SUNDAY MARCH 15, 2020, FROM 7:00 AM TO 12:00 PM; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the National Kidney Foundation of Florida (“Applicant”) seeks approval from the City of Doral for a Special Event Permit; and

**WHEREAS**, staff recommends Council to approve the proposed Special Event Permit to host the “2020 Doral Kidney Walk” Event on Sunday, March 15, 2020, located at Doral Central Park, 3000 NW 87 Avenue, Doral, FL 33172.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are true and correct and incorporated herein.

**Section 2. Approval.** The Special Event Permit for the “2020 Doral Kidney Walk” is hereby approved subject to the following conditions:

1. Applicant shall comply with the comments made by the City of Doral Parks and Recreation Department.
2. Applicant shall comply with the comments made by the City of Doral Police Department.
3. Applicant shall comply with all Building Permits and Inspections required by the Building Department prior to the event start date.
4. Applicant is responsible to pay all outstanding City fees prior to the issuance

of the Special Event Permit.

**Section 3. Effective Date.** This Resolution shall take effect immediately upon adoption.
