

**RESOLUTION NO. 11 – 79**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FL RATIFYING THE ADOPT-A-STREET LITTER REMOVAL AGREEMENT WITH DHL EXPRESS (USA) FOR THE PROVISION OF LITTER REMOVAL ACTIVITIES ALONG N.W. 18<sup>TH</sup> TERRACE BETWEEN N.W. 87<sup>TH</sup> AVENUE AND N.W. 89<sup>TH</sup> PLACE; N.W. 89<sup>TH</sup> PLACE BETWEEN N.W. 18<sup>TH</sup> TERRACE AND N.W. 25<sup>TH</sup> STREET; N.W. 24<sup>TH</sup> STREET BETWEEN N.W. 89<sup>TH</sup> PLACE AND N.W. 88<sup>TH</sup> COURT; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral, through Resolution #05-12, established an "Adopt-A-Street" Program permitting local organizations, private corporations and volunteer groups to beautify City-maintained roads through litter-removal activities and landscaping efforts; and

**WHEREAS**, DHL Express USA wishes to adopt N.W. 18<sup>th</sup> Terrace between N.W. 87<sup>th</sup> Avenue and N.W. 89<sup>th</sup> Place; N.W. 89<sup>th</sup> Place between N.W. 18<sup>th</sup> Terrace and N.W. 25<sup>th</sup> Street; and N.W. 24<sup>th</sup> Street between N.W. 89<sup>th</sup> Place and N.W. 88<sup>th</sup> Court; and

**WHEREAS**, Staff respectfully requests that the City Council ratify the Adopt-A-Street Program Litter Removal Agreement with DHL Express USA for the provision of litter removal activities along N.W. 18<sup>th</sup> Terrace between N.W. 87<sup>th</sup> Avenue and N.W. 89<sup>th</sup> Place; N.W. 89<sup>th</sup> Place between N.W. 18<sup>th</sup> Terrace and N.W. 25<sup>th</sup> Street; and N.W. 24<sup>th</sup> Street between N.W. 89<sup>th</sup> Place to N.W. 88<sup>th</sup> Court.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1.** The City Council hereby ratifies the Adopt-A-Street Program Litter Removal Agreement with A Plus Bus USA Corp for the provision of litter removal activities along N.W. 18<sup>th</sup> Terrace between N.W. 87<sup>th</sup> Avenue and N.W. 89<sup>th</sup> Place; N.W. 89<sup>th</sup> Place between N.W. 18<sup>th</sup> Terrace and N.W. 25<sup>th</sup> Street; and N.W. 24<sup>th</sup> Street between N.W. 89<sup>th</sup> Place and N.W. 88<sup>th</sup> Court.

**Section 2.** This Resolution shall become effective immediately upon its adoption.
