## **RESOLUTION No. 20-22**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO ENTER INTO AN INTERLOCAL AGREEMENT FOR ACCESS TO CERTAIN EXEMPT INFORMATION MAINTAINED BY THE MIAMI-DADE COUNTY PROPERTY APPRAISER; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, The Florida Legislature amended section 119.071(4)(d), Florida Statutes, regarding property owner information that is exempt from public disclosure, to define the term "home addresses" for purposes of public records exemptions for personal identifying and location information; and

WHEREAS, Since the amended statute requires the Property Appraiser to redact key property identifiers such as the property and mailing address, folio number, legal description and GPS coordinates, the record is rendered unusable when the information is transmitted electronically to the City of Doral. To obtain the one-time population information of the records that are exempt in order to flag them in our permitting system we must sign the Interlocal Agreement with the Property Appraisers Office.

WHEREAS, In addition, the City of Doral Information Technology Department will work with the Property Appraisers Information Technology Department to develop a recurring interface with the one-offs to continuously update our permitting system records; and.

WHEREAS, Staff recommends the Mayor and City Council authorize the City Manager to enter into an Interlocal Agreement for Access to Certain Exempt Information Maintained by the Miami Dade County Property Appraiser.
