A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A WORK ORDER BETWEEN THE CITY OF DORAL AND R.J. BEHAR AND COMPANY, INC., A PREQUALIFIED CITY VENDOR, FOR THE PROVISION OF TRAFFIC STUDY REVIEWS ON AN AS NEEDED BASIS TO ASSIST THE CITY'S TRANSPORTATION DIVISION IN AN AMOUNT NOT TO EXCEED \$28,343.68; AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City") continues to experience an high number of

private development applications that require traffic study reviews; and

WHEREAS, there is a need for the services of an independent consultant to assist

the City's Transportation Division with the review of traffic studies on an as needed basis;

and

WHEREAS, R.J. Behar and Company, Inc. is a prequalified provider of professional

engineering services selected in accordance with Consultant Competitive Negotiation Act

requirements and approved by the City Council in December 2014; and

WHEREAS, Staff recommends that the City Council approve a work order with R.J.

Behar and Company, Inc. for the provision of traffic study reviews to assist the City's

Transportation Division in an amount not to exceed \$28,343.68 (the "Work Order");

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true, correct and incorporated herein and made a part hereof by this reference.

Section 2. Approval. The Work Order between the City of Doral and R.J. Behar and Company, Inc. for traffic study reviews on an as needed basis, in an amount not to exceed \$28,343.68, attached hereto as Exhibit "A", which is incorporated herein and made a part hereof by this reference, is hereby approved.

Section 3. Authorization. The City Manager is authorized to execute the Work Order and expend budgeted funds on behalf of the City in furtherance hereof.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
