A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT REQUESTED BY CANNONBALL PRODUCTIONS TO HOST THE "SELTZERLAND" AT COSTA DEL SOL GOLF COURSE, LOCATED AT 100 COSTA DEL SOL BLVD ON SATURDAY, APRIL 9, 2022, FROM 11:00 AM TO 7:00 PM; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Cannonball Productions (the "Applicant") seeks approval from the City of Doral of a special event permit to host "Seltzerland"; and

WHEREAS, Seltzerland is an event to promote local businesses and will donate part of the proceeds to food education groups; and

WHEREAS, staff recommends that the Mayor and City Council approve the proposed special event permit to host "Seltzerland," Saturday, April 9, 2022, at Costa del Sol Golf Course, located at 100 Costa Del Sol, Doral from 11:00 a.m. to 7:00 p.m.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made as part hereof by this reference.

<u>Section 2.</u> Approval. The special event permit for the "Seltzerland" is hereby approved subject to the following conditions:

- 1. The Applicant shall secure all necessary and required building, electrical, plumbing, or other permits, and shall immediately furnish proof of such permits upon request from the city.
- 2. Applicant shall be required to have all inspections and approvals prior to the event date.
- 3. Sanitary facilities shall be provided by the Applicant and shall be of the type and in a sufficient number as to meet the requirements established by the

Building Department.

- 4. The Applicant is responsible for providing adequate security at the special event. The police department may require the Applicant to provide and pay for security personnel for crowd control and traffic direction purposes. The county fire rescue department may require the Applicant to provide and pay for fire watch personnel.
- 5. Applicant shall comply with comments made by the City of Doral Police Department and pay all applicable fees no later than 14 days in advance of the event.
- 6. Applicant shall obtain applicable permit(s) from the Division of Alcohol Beverages and Tobacco.

<u>Section 3.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon its adoption.
