### INTERLOCAL AGREEMENT BETWEEN THE CITY OF DORAL AND MIAMI-DADE COUNTY FOR SURPLUS VEHICLES SALE, MISCELLANEOUS ELECTRONIC EQUIPMENT AND OFFICE FURNITURE

THIS INTERLOCAL AGREEMENT, (the "Agreement") by and between Miami-Dade County (hereinafter referred to as "The County") and the City of Doral (hereinafter referred to as "The City") is entered into this <u>6</u> day of <u>3999</u>, 2014.

WHEREAS, The City wishes to utilize the services of The County for the sale of The City surplus properties, including but not limited to vehicles, miscellaneous electronic equipment, office furniture (the "Surplus Property"); and

WHEREAS, The County wishes to provide this service to The City.

NOW, THEREFORE, the parties do mutually agree to the following term and conditions:

1. TERM:

This Agreement shall commence on  $3 \sqrt{2014}$ , and continue indefinitely, subject to the right of either party to terminate at any time within 30 days written notice.

2. SERVICES:

Miami-Dade County, Internal Services Department, Administrative and Business Services Division (hereinafter referred to as ISD/ABSD) agrees to provide the following services to The City regarding the sale of their Surplus Property:

- a) ISD/ABSD will advertise and conduct the administrative functions related to the sale of Surplus Property in accordance with Chapter 274 of the Florida Statutes.
- b) The sale of the Surplus Property will be conducted in conjunction with the next available sale of The County surplus property. All sales will be advertised and conducted "As Is-Where Is" with no warranty or guaranty of any kind.
- c) Successful bidders will be notified of their award by ISD/ABSD, and instructed to pay for their purchase at ISD/ABSD, 2225 N.W. 72<sup>nd</sup> Avenue, Miami, Florida. All proceeds will be made payable to Miami-Dade County.
- d) Upon receipt of payment in full, ISD/ABSD will provide the buyer with a "Paid in Full" receipt and a "Notice of Award".
- 3. City of Doral Responsibilities:

The City will be responsible for the following functions of the sale:

- a) Notification to ISD/ABSD of vehicles for sale including the following information: Make, Model, Year, Color, Vehicle Identification Number, Statement as to road operability (running or non-running), and identification of use as a police/fire emergency response unit.
- b) Vehicles must be fully prepared for sale at the time the bid solicitation commences. Preparation of vehicles for sale requires the removal of license plates, removal of emergency or radio equipment, and the removal of any identifying decals or logos.
- c) The following forms must be completed for each vehicle (copies attached) Buyers Guide (completed and affixed to window of vehicle) (please check box for AS-IS NO WARRANTY), and a Certification of Pollution Control Devices or Systems form.
- d) With regards to The City's Surplus Property other than vehicles, The City has identified the properties listed in the attached Exhibit "A" which will be sold by The County.
- e) The City will identify: the address/location where the items may be inspected by prospective bidders; the same and telephone number of a contact person who will be available to show items to prospective bidders; and the hours and days when prospective bidders may make appointments to inspect the items, e.g. 8:00 A.M. to 3:00 P.M., Monday through Friday.
- f) The City will retain custody of the vehicle(s) and Certificate(s) of Title, until such time as the City receives the "Paid in Full" receipt issued by ISD/ABSD from the awarded bidder at which time The City shall release custody of the vehicle and effect the transfer of the Certificate of Title to the awarded bidder.
- g) For properties other than vehicles, The City shall prepare a Bill of Sale for the particular item(s) transferring the properties to the awarded bidder once The City receives the "Paid in Full" receipt issued by ISD/ABSD.

#### 4. PAYMENT FOR SERVICES:

Upon completion of the sale, the ISD/ABSD will provide a summary of the sale results. ISD/ABSD will then deduct 20% of the proceeds as compensation for services provided. A check will be made out within 60 days following the issuance of the "Paid in Full" receipt to the buyer; The County shall disburse 80% of the proceeds of the sale to The City.

#### 5. INDEMNIFICATION:

The City shall indemnify and hold harmless The County and its officers, employees, agents, and instrumentalities from any and all liability, losses or damages, including attorneys' fees and costs of defense, which The County or its officers, agents, and instrumentalities may incur as a result of claims, demands, suits, causes of actions or proceeding of any kind arising out of, relating to or resulting from the advertising and sale of The City's surplus vehicles.

The City shall pay all claim and losses in connection therewith and shall investigate and defend all claims, suits or actions of any kind or nature in the name of The County, where applicable, which may issue thereon. Provided, however, this indemnification shall only be to the extent and within the limitations of Section 768.28 Florida Statutes, subject to the provisions of that Statute whereby the government entity shall not be held liable to pay personal injury or property damage claims or judgments or portions thereof, which when totaled with all other claims or judgments paid by the government entity arising out of the same incident or occurrence, exceed the sum of \$200,000, from any and all personal injury or property damage claims, liabilities, losses or causes of action which may arise as a result of the negligence of the government entity.

The agreement contains the entire understanding between the parties and it may be amended by joint agreement in writing by both parties.

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA APPROVING AN INTERLOCAL AGREEMENT WITH MIAMI-DADE COUNTY FOR THE SALE OF FORTY ONE (41) INVENTORIED MISCELLANEOUS ELECTRONIC EQUIPMENT; AUTHORIZING THE CITY MANAGER TO EXECUTE THE INTERLOCAL AGREEMENT ON BEHALF OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral currently has forty-one (41) inventoried various surplus electronic equipment, including, but not limited to, speakers, amplifiers, mixers, etc.; and

WHEREAS, the technology of the equipment has become outdated and obsolete, thus the need to take the items out of circulation becomes necessary; and

WHEREAS, Miami-Dade County, Internal Services Department, Administration and Business Services Division has an existing sales program in which used equipment, is sold in accordance with Chapter 274, Florida Statutes, and provides this service to municipalities through Interlocal agreements; and

WHEREAS, all sales will be conducted "As Is-Where Is" with no warranty or guarantee of any kind; and

WHEREAS, upon completion of the sale, Miami-Dade County will provide a summary of the sales results and will then deduct 20% of the proceeds as compensation for services provided; and

WHEREAS, Miami-Dade County will issue a check to the City of Doral in the amount of 80% of the proceeds of the sale.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AS FOLLOWS: Section 1. <u>Recitals.</u> The foregoing recitals are true and correct and incorporated herein.

<u>Section 2.</u> <u>Authorization.</u> The Mayor and City Council of the City of Doral, Florida herby authorizes the City Manager to enter into an Interlocal Agreement with Miami-Dade County consistent with this Resolution to conduct an auction for miscellaneous electronic equipment that is no longer being used by the City of Doral.

Section 3. Effective Date. This Resolution shall take effect immediately upon adoption.
