

**RESOLUTION No. 19-17**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE OVERAGE PAYMENT OF \$2,072.72 FROM AT&T DUE TO PRORATED RATES AND WIRELESS CARRIER FEES TO BE PAID FROM ACCOUNT 001.22005.500410, "COMMUNICATIONS AND FREIGHT" THROUGH THE IT DEPARTMENT; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the Police Department for the City of Doral (the "City") is requesting the overage amount of \$2,072.72 to be paid; and

**WHEREAS**, the Mayor and Council approved the purchase of 136 AT&T Fleet Complete trackers in September 2018 per Resolution No. 18-154. The Information Technology (IT) Department budgeted for this item during FY17-18 for all services rendered. The Palm Beach County contract was used to procure those services. The IT Department received their first monthly statement showing a rate of \$31.22 per device due to proration (one-time charge) and wireless carrier fees, instead of \$18.00 per the Resolution. Moving forward the amount per device including wireless carrier fees is \$21.00 per device, which was budgeted for; and

**WHEREAS**, Staff further requests that the City Council authorize the overage payment to be paid in the amount of \$2,072.72.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval.** The City Manager is hereby authorizing the overage payment of \$2,072.72 due to prorated and wireless carrier fees with AT&T per the Palm

Beach County contract to be paid from account #001.22005.500410, Communications and Freight through the IT Department and continue the monthly charge of \$2,922.64.

**Section 3. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

**Section 4. Effective Date.** This Resolution shall become effective immediately upon its adoption.

The foregoing Resolution was offered by Vice Mayor Mariaca who moved its adoption. The motion was seconded by Councilmember Cabral and upon being put to a vote, the vote was as follows:
