

RESOLUTION NO. 12 – 151

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, CERTIFYING AND DECLARING THE RESULTS OF THE GENERAL ELECTION HELD ON NOVEMBER 6, 2012 AND RUN-OFF ELECTION HELD ON NOVEMBER 27, 2012; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, a General Election has been held in the City of Doral, Florida in accordance with the law on November 6, 2012 for the purpose of electing a Mayor and Councilmembers for Seats 1, 2 and 3; and

WHEREAS, the General Election resulted in a winner for Council Seat 2 and, due to the other races not having candidates who received more than 50% plus one (1) vote in this election, a Run-Off Election was necessary to determine a winner for the Mayoral Seat, Council Seat1, and Council Seat 3; and

WHEREAS, the Miami-Dade Canvassing Board canvassed the votes cast in the November 6, 2012 General Election; and

WHEREAS, a Run-Off Election has been held in the City of Doral, Florida in accordance with the law on November 27, 2012 for the purpose of electing a Mayor and Councilmembers for Seats 1 and 3; and

WHEREAS, the City of Doral Canvassing Board canvassed the votes cast in said Run-Off Election.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:




