A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT REQUESTED BY FUNDACION VALLENATA USA TO HOST THE "FESTIVAL VALLENATO USA" AT DOWNTOWN DORAL PARK, LOCATED AT 8395 NW 53 STREET, DORAL, FLORIDA, 33166 FROM SATURDAY, OCTOBER 22, 2022, TO SUNDAY, OCTOBER 23, 2022, FROM 12:00 PM TO 10:00 PM; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Fundación Vallenata USA (the "Applicant") seeks approval from the City of Doral of a special event permit to host "Festival Vallenato USA" at Downtown Doral Park, and

WHEREAS, the Applicant has requested that the City co-sponsor the event and contribute a total of \$5,000 which are the projected costs, from the General Government-Other Current Charges account 001.50005.500490; and

WHEREAS, the Applicant further seeks authorization from the City to use the city logo; and

WHEREAS, staff recommends that the Mayor and City Council approve the proposed special event permit to host "Festival Vallenato USA," from Saturday, October 22, 2022, to Sunday, October 23, 2022 at Downtown Doral Park, located at 8395 NW 53 Street, Doral from 12:00 p.m. to 10:00 p.m. Staff makes no recommendation on the request for sponsorship.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made as part hereof by this reference.

<u>Section 2.</u> Approval. The Mayor and City Council hereby direct the City Manager and City Attorney to draft a sponsorship agreement between the City of Doral and Applicant in accordance with the City's Code of Ordinances. The special event permit for the "Festival Vallenato USA" is hereby approved subject to the following conditions:

- The Applicant shall secure all necessary and required building, electrical, plumbing, or other permits, and shall immediately furnish proof of such permits upon request from the city.
- 2. The Applicant shall be required to have all inspections and approvals prior to the event date.
- Sanitary facilities shall be provided by the Applicant and shall be of the type and in a sufficient number as to meet the requirements established by the Building Department.
- 4. The Applicant is responsible for providing adequate security at the special event. The police department may require the Applicant to provide and pay for security personnel for crowd control and traffic direction purposes. The county fire rescue department may require the Applicant to provide and pay for fire watch personnel.
- 5. The Applicant shall comply with comments made by the City of Doral Police Department and pay all applicable fees no later than 14 days in advance of the event.
- 6. The Applicant shall comply with comments made by the City of Doral Parks and Recreation Department and pay all applicable fees no later than 14 days in advance of the event.
- 7. The Applicant shall provide to the City of Doral an acceptable certificate of insurance naming the city as an additional insured four (4) weeks prior to the event date.
- 8. The Applicant shall provide copy of parking agreement(s) to the Planning and Zoning Department thirty (30) days prior to event start date.

<u>Section 3.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon its adoption.
