A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY'S CODE OF ORDINANCES, APPROVING THE PURCHASE OF ONE (1) CISCO NEXUS 9200 NETWORK SWITCH TO REPLACE UPCOMING END OF LIFE EQUIPMENT FOR OUR MAIN DATA CENTER FROM PC SOLUTIONS AND INTEGRATION. INC., VIA THE STATE OF FLORIDA CONTRACT NASPO: NVP #AR233 (14-19) PARTICIPATING ADDENDUM FOR FL #43220000-WSCA-14-ACS IN AN AMOUNT NOT TO EXCEED \$21,602.20; AUTHORIZING THE CITY MANAGER TO **EXECUTE** CONTRACTUAL DOCUMENTS AND EXPEND BUDGETED FUNDS **FURTHERANCE** HEREOF: PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City") has to replace Cisco network equipment that are end of life and no support for our main data center; and

WHEREAS, the Cisco network equipment is compatible with the City's current network infrastructure; and

WHEREAS, section 2-322 of the City Code of Ordinances provides that the City may enter into contracts competitively entered into by other governmental entities; and

WHEREAS, PC Solutions & Integration, Inc. ("PCS") is a vendor participating in State of Florida Contract NASPO; NVP #AR233 (14-19) PARTICIPATING ADDENDUM FOR FL No. 43220000-WSCA-14-ACS with Cisco Systems, and PCS has provided terms for the purchase of certain "Cisco Network Equipment," as specified in the quote attached hereto as Exhibit "A" (the "Quote"), which is incorporated herein and made a part hereof by this reference; and

WHEREAS, staff has recommended the Mayor and City Council Members purchase the Cisco Network Equipment from PCS in accordance with the Quote in the

amount of **\$21,602.20**, which has been competitively bid and is competitive even as compared to other providers selling via the State Contract, with funds payable from "Capital" account #001.60005.500640 with a transfer from Repair and Maintenance Account #001.22005.500460.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval. Pursuant to section 2-322 of the City Code of Ordinances, the procurement of the Cisco Network Equipment from PCS, via State of Florida Contract NASPO; NVP #AR233 (14-19) PARTICIPATING ADDENDUM FOR FL No. 43220000-WSCA-14-ACS with Cisco Systems, in accordance with its quote in Exhibit "A", in an amount not to exceed \$21,602.20, is hereby approved.

<u>Section 3.</u> Authorization. The City Manager is hereby authorized to enter into an agreement and other contractual documents, subject to approval as to form and legal sufficiency by the City Attorney, as may be necessary to procure the Cisco Network Equipment, and to expend funds in furtherance hereof.

Section 4. Implementation. The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
