

**RESOLUTION No. 17-39**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY CODE OF ORDINANCES, APPROVING THE PURCHASE OF 25 POLICE VEHICLES IN AN AMOUNT NOT TO EXCEED \$599,041.54 VIA THE AGREEMENT WITH THE STATE OF FLORIDA AND DON REID FORD; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT, SUBJECT TO APPROVAL AS TO FORM AND LEGAL SUFFICIENCY BY THE CITY ATTORNEY, AND TO EXPEND BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the Police Department for the City of Doral (the “City”) seeks to purchase 25 vehicles from Don Reid Ford as follows: Two (2) K-9 SUV’s and 23 Uniform Patrol Sedans; and

**WHEREAS**, section 2-322 of the City Code Ordinances provides that City may enter into bids or contracts entered into by other governmental authorities provided that the governmental authority has followed a competitive bidding procedure leading to the award of the bid or contract in question which is substantially similar to the competitive bidding procedures required by the City; and

**WHEREAS**, Don Reid Ford and the State of Florida entered into a contract for the purchase and sale of fleet vehicles, which was competitively procured in a manner similar to that set forth in the City’s procurement regulations (the “State Contract”); and

**WHEREAS**, Staff has recommended that the City Council authorize the City Manager to negotiate and enter into an agreement with Don Reid for the purchase of 25 police vehicles in an amount not to exceed \$599,041.54 via the State Contract.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF  
THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The foregoing recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval.** Pursuant to section 2-322 of the City Code of Ordinances, the purchase of 25 police vehicles from Don Reid Ford in an amount not to exceed \$599,041.54 via the State Contract is hereby approved. This purchase is funded in account 001.60005.500641 Capital Outlay-Vehicles.

**Section 3. Authorization.** The City Manager is hereby authorized to enter into an agreement and other contractual documents, subject to approval as to form and legal sufficiency by the City Attorney, as may be necessary to procure the Vehicles under the State of Florida contract with Don Reid, and to expend funds in furtherance thereof, in amounts not to exceed \$599,041.54.

**Section 4. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

**Section 5. Effective Date.** This Resolution shall become effective immediately upon its adoption.

The foregoing resolution was offered by Vice Mayor Cabrera who moved its adoption. The motion was seconded by Councilmember Rodriguez and upon being put to a vote, the vote was as follows:
