A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA APPROVING AN OUTDOOR EVENT PERMIT FOR ARMS OF LOVE CHARITIES TO PERMIT THE "THANKSGIVING LATIN FESTIVAL" EVENT TO TAKE PLACE AT JC BERMUDEZ PARK LOCATED AT 3000 NW 87<sup>TH</sup> AVENUE ON SATURDAY, NOVEMBER 20<sup>TH</sup>, 2010 FROM 12:00 PM TO 10:00 PM; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Arms of Love Charities ("Applicant") seeks approval from the City of Doral for an Outdoor Event Permit; and

WHEREAS, Arms of Love Charities ("Applicant") also seeks the waiving of the Parks and Recreation Department's \$800.00 park rental fee; and

WHEREAS, Staff respectfully recommends that Council approve the proposed Outdoor Event Permit for the Arms of Love Charities, "Thanksgiving Latin Festival" event to be held Saturday, November 20<sup>th</sup>, 2010 from 12:00 pm to 10:00 pm at JC Bermudez Park located at 3000 NW 87<sup>th</sup> Avenue subject to the following conditions:

- 1. Construction plans outdoor structural facility must be submitted to the Building Department for approval.
- 2. An agreement with the City of Doral Police must be established prior to the beginning of the event.
- 3. All necessary rental, clean-up and staff fees, pursuant to the fee schedule attached, must be furnished to the Parks and Recreation Department prior to the event. (Park Rental Fee waived as indicated above)
- 4. Applicant shall provide staff a certificate of good standing from the State of Florida confirming that the corporation is in good standing under Florida law.
- 5. Applicants will be allowed access to the park until 11:30 pm for event clean up
