

**RESOLUTION No. 20-59**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-321 OF THE CITY'S CODE OF ORDINANCES, APPROVING THE PURCHASE OF 15 BALLISTIC SHIELDS IN AN AMOUNT NOT TO EXCEED \$21,450.00 FROM SRT SUPPLY, A SOLE SOURCE VENDOR; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT, SUBJECT TO APPROVAL AS TO FORM AND LEGAL SUFFICIENCY BY THE CITY ATTORNEY, FOR THE PURCHASE; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral Police Department requests to purchase 15 Ballistic Shields; and

**WHEREAS**, the Police Department respectfully requests to purchase 15- Ballistic Shields from SRT Supply, a sole source vendor. During the past two (2) years, City of Doral Police officers have responded to four (4) active shooter incidents in which the use of ballistics shields could have been utilized as part of the first responding officer's tactical response. The availability of the ballistic shields for first responding officers can provide officers with a tactical advantage and enhance officer's safety, while working to neutralize a threat to themselves and the general public; and

**WHEREAS**, Pursuant to Section 2-321 of the City Code, Staff respectfully requests that the City Council authorize the City Manager to negotiate and enter into an agreement with SRT Supply, a sole source vendor for the purchase of 15 Ballistic Shields in an amount equal to \$21,450.00, and further requests that the City Council authorize the City Manager to expend budgeted funds on behalf of the City with respect to the agreement approved herein.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL  
OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval.** Pursuant to section 2-321, the purchase of 15 Ballistic Shields from SRT Supply, a sole source vendor in an amount not to exceed \$21,450.00 is hereby approved. This purchase is funded from the Capital Outlay-Office Account #001.60005.500640.

**Section 3. Authorization:** The City Manager is hereby authorized to enter into an agreement and other contractual documents, subject to approval as to form and legal sufficiency by the City Attorney, as may be necessary to procure the Ballistic Shields under the sole source letter provided by SRT Supply to expend funds in furtherance thereof in amounts not to exceed \$21,450.00.

**Section 4. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

**Section 5. Effective Date.** This Resolution shall take effect immediately upon adoption.
