## **RESOLUTION No. 22-47**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT TO HOST THE "MIAMI CITY BALLET ANNUAL FUNDRAISING GALA" AT DOWNTOWN DORAL PARK, LOCATED AT 8395 NW 53 STREET, DORAL, FL 33166, ON THURSDAY, APRIL 7, 2022, FROM 7:00 PM TO 12:00 AM; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Miami City Ballet (the "Applicant") seeks approval from the City of Doral

of a special event permit to host the "Miami City Ballet Annual Fundraising Gala"; and

WHEREAS, the purpose of the Miami City Ballet Annual Fundraising Gala is to

gather supporters in the spirit of unity and gratitude, and relish an evening of artistic excellence and enjoyment featuring Alexei Ratmansky's Swan Lake; and

WHEREAS, staff recommends that the Mayor & City Council approve the proposed

special event permit to host the "Miami City Ballet Fundraising Gala" on Thursday, April 7,

2022 at Downtown Doral Park, located at 8395 NW 53 Street, Doral, FL 33166, from 7:00

p.m. to 12:00 a.m.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

**Section 1. Recitals.** The foregoing recitals are confirmed, adopted, and incorporated herein and made as part hereof by this reference.

**Section 2. Approval.** The special event permit for the "Miami City Ballet Annual Fundraising Gala" is hereby approved subject to the following conditions:

1. The Applicant shall secure all necessary and required building, electrical, plumbing, or other permits, and shall immediately furnish proof of such permits upon request from the city.

- 2. Applicant shall be required to have all inspections and approvals prior to the event date.
- 3. Sanitary facilities shall be provided by the Applicant and shall be of the type and in a sufficient number as to meet the requirements established by the Building Department.
- 4. The Applicant is responsible for providing adequate security at the special event. The police department may require the Applicant to provide and pay for security personnel for crowd control and traffic direction purposes. The county fire rescue department may require the Applicant to provide and pay for fire watch personnel.
- 5. Applicant shall comply with comments made by the City of Doral Police Department and pay all applicable fees.
- 6. Applicant shall comply with comments made by the City of Doral Parks and Recreation Department and pay all applicable fees.
- 7. Applicant shall provide to the City of Doral an acceptable certificate of insurance naming the city as an additional insured prior to the event date.

Section 3. Effective Date. This Resolution shall take effect immediately upon

adoption.
