

**RESOLUTION NO. 13-63**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE DORAL, FLORIDA AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH GANNETT FLEMING (GF) FOR THE PROVISION OF CONSTRUCTION ENGINEERING INSPECTION (CEI) SERVICES FOR CONSTRUCTION AND INSTALLATION OF BUS SHELTERS AND CONCRETE BENCH PADS AS PART OF THE CITYWIDE DORAL TROLLEY INFRASTRUCTURE IMPROVEMENTS PLANNED FOR EXISTING TROLLEY ROUTES 1 AND 2 IN AN AMOUNT NOT TO EXCEED \$34,152.00; AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY WITH RESPECT TO THE AGREEMENT APPROVED HEREIN; RECOGNIZING THAT GANNETT FLEMING IS A CITY OF DORAL PRE-QUALIFIED VENDOR; AND PROVIDING FOR AN EFFECTIVE DATE (PUBLIC WORKS)**

**WHEREAS**, the City of Doral Public Works Department wishes to secure a firm to provide Construction Engineering Inspection (CEI) Services for construction and installation of bus shelters and concrete bench pads as part of the citywide Doral trolley infrastructure improvements planned for existing trolley routes 1 and 2; and

**WHEREAS**, Staff has determined that Gannett Fleming (GF), one of ten (10) City of Doral pre-qualified vendors for professional engineering services, would be best qualified to offer these services; and

**WHEREAS**, Staff respectfully requests that the City Council authorize the City Manager to negotiate and enter into an agreement with Gannett Fleming (GF), for construction engineering inspection (CEI) services for construction and installation of bus shelters and concrete bench pads as part of the citywide Doral trolley infrastructure improvements planned for existing trolley routes 1 and 2 in an amount not to exceed \$34,152.00; and

**WHEREAS**, Staff further requests that the City Council authorize the City Manager to expend budgeted funds on behalf of the City with respect to the agreement approved herein.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1.** Recognizing that Gannett Fleming (GF), is a City of Doral pre-qualified vendor, the City Council of the City of Doral hereby authorizes the City Manager to negotiate and enter into an agreement with Gannett Fleming (GF), for the provision of construction engineering inspection (CEI) services for construction and installation of bus shelters and concrete bench pads as part of the citywide Doral trolley infrastructure improvements planned for existing trolley routes 1 and 2 in an amount not to exceed \$34,152.00.


**Section 2.** The City Council further authorizes the City Manager to expend budgeted funds on behalf of the City with respect to the agreements approved herein.
