

**RESOLUTION No.17-28**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING AN OUTDOOR EVENT PERMIT FOR RENAISSANCE CHARTER SCHOOL TO HOST THE “GLOW IN THE DARK 5K” EVENT AT DORAL CENTRAL PARK LOCATED AT 3000 NW 87 AVENUE, DORAL, FLORIDA 33172, ON SATURDAY, MARCH 4, 2017 FROM 4:30PM TO 8:30PM; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the Renaissance Elementary School (“Applicant”) seeks approval from the City of Doral for an Outdoor Event Permit, as per the application and exhibits attached hereto as Exhibit “A”, which is incorporated herein and made a part hereof by this reference; and

**WHEREAS**, staff has recommended that Council approve the Applicant’s proposed Outdoor Event Permit to host “Glow in the Dark 5K” event on Saturday, March 4, 2017 from 4:30pm to 8:30pm at Doral Central Park located at 3000 NW 87<sup>th</sup> Avenue, Doral, Florida 33172.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval.** The outdoor event permit for “Glow in the Dark 5K” event is hereby approved, subject to the following conditions:

1. Compliance with the comments made by the City of Doral Police Department, as provided in Exhibit “B”;
2. Acquisition of all required permits and performance of all inspections prior to event start date, consistent with the City of Doral Building Department requirements;

3. Compliance with the comments set forth by the Parks and Recreation Department, as provided in Exhibit "C"; and
4. Payment of all fees and costs as provided in Exhibit "D".

All the foregoing Exhibits are incorporated herein and made a part hereof by this reference.

**Section 3. Implementation.** The City Manager and the City Attorney re hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

**Section 4. Effective Date.** This Resolution shall become effective immediately upon adoption.
